1. SIMPLIFICATION - INTEGRATED ADMINISTRATION AND CONTROL SYSTEM (IACS):

Presentation and exchange of views on a Working document amending the Implementing Regulation (EU) No 809/2014 laying down rules for the application of Regulation (EU) No 1306/2013 of the European Parliament and the Council with regard to the integrated administration and control system, rural development measures and cross-compliance – **DS/CDP/2016/01**

The Commission representatives presented the draft working document stated above. The purpose of this working document is to adapt the Implementing Regulation (EU) No 809/2014 to complement a simplification proposal introduced in the Delegated Regulation (EU) No 640/2014 as regards the administrative penalties. Member States (MS) expressed their opinion and comments about this document.

2. INTEGRATED ADMINISTRATION AND CONTROL SYSTEM (IACS):

Request for information regarding the Working document on the increase in the percentage of beneficiaries to be checked in the context of greening where significant non-compliances are found - **DS/CDP/2015/19-Rev 2**

The Commission representatives presented the third version of this draft working document where only minor modifications have been done in comparison to the previous version.

Some particular questions have been raised by MS to which the Commission services replied.

Beyond that, MS have been officially asked to send to DG AGRI specific information (Note to the Member States Representatives of the Direct Payments Committee – Ares(2016)217880 – 15/01/2016), via the excel tables provided on CircaBC, in view of further analysing the methodology to be applied for the purpose of this working document.
