Presentation and exchange of views on a Working document amending the Implementing Regulation (EU) No 809/2014 laying down rules for the application of Regulation (EU) No 1306/2013 of the European Parliament and the Council with regard to the integrated administration and control system, rural development measures and cross-compliance – **DS/CDP/2016/01-Rev1**

The Commission representatives presented the revised version of the draft working document stated above.

Member States expressed their views about the proposed amendment related to the obligation to check 100% of all beneficiaries who, in the previous claim year, were both checked on-the-spot and benefitted from a reduced penalty in accordance with the newly introduced Article 19a(2) of Regulation (EU) No 640/2014.
