All Member States were present except Cyprus.

1. SIMPLIFICATION IMPLEMENTING ACT DP (HEMP):

Presentation and exchange of views on the draft Commission Implementing Regulation (EU) .../... of XXX amending Implementing Regulation (EU) No 809/2014 laying down rules for the application of Regulation (EU) No 1306/2013 of the European Parliament and of the Council with regard to the integrated administration and control system, rural development measures and cross compliance regarding the control measures for the cultivation of hemp - **DS/CDP/2016/07**

The Commission representative presented the draft underlining the two main aims of the proposal: 1. to solve the legal problem of the inadequate qualification as delegated or implementing rules of certain of the existing hemp provisions. 2. to adapt the procedure concerning the determination of the hemp varieties eligible for the basic payment and for the control of the content of the THC content to the special characteristics of the production of hemp as a catch crop. An exchange of views took place and further clarifications were given to certain issues.
