## SUMMARY RECORD

*Meeting of the Committee for direct payments*

*25/04/2017 - Brussels*

Delegations present: All Member States were present or represented, except Croatia.

### **1. Budgetary ceilings for 2017:**

Presentation of a draft Commission Implementing Regulation (EU) .../... establishing budgetary ceilings for 2017 applicable to certain direct support schemes provided for in Regulation (EU) No 1307/2013 of the European Parliament and of the Council - DS/CDP/2017/01 & DS/CDP/2017/02.

The Commission representative presented the draft regulation as well as the working document and explained that, should the formal inter-service consultations end in due time, the opinion of the Committee will be asked on 23 May 2017.

### **2. Integrated Administration and Control System (IACS):**

(a) Presentation and exchange of views on a document on how to revise the guidance for on-the-spot checks and area measurement

The Commission presented a revised document proposing some flexibility for CY2017 regarding the random selection of the control zones and then the risk analysis inside the zones for on-the-spot checks. The Commission proposed also more flexibility regarding the control period of the ban on the use of Plant Protection Products. The Commission clarified administrative checks related to the ban on the use of PPP, proposing a check-box on the aid-application form.

(b) Presentation and exchange of views on a document how to revise the guidance document for the Land Parcel Identification System

Following the positive feedback of the last Committee meeting (March 23, 2017), Commission proposed not to further discuss this point. The Committee did not raise any remarks this time either.

### 3. **AOB**

The Commission presented a working document to facilitate the discussion on a Commission Implementing Regulation derogating from Implementing Regulation (EU) No 809/2014 as regards the final date of submission of the single application, aid applications or payment claims, the final date for notification of amendments to the single application or payment claim and the final date for applications for allocation of payment entitlements or the increase of the value of payment entitlements under the basic payment scheme for the year 2017.

The Commission asked for a written notification from the MS who are willing to apply the derogation.
