1) **New technologies: Integrated Administration and Control System (IACS)**

Presentation and exchange of views on introducing monitoring approaches into IACS and amending the Implementing Regulation (EU) No 809/2014 laying down rules for the application of Regulation (EU) No 1306/2013 of the European Parliament and the Council with regard to the integrated administration and control system, rural development measures, and cross-compliance – DS/CDP/2017/03.

The Commission presented its view on introducing monitoring approaches into IACS and amending the Implementing Regulation (EU) No 809/2014 and related guidance documents with regard to the integrated administration and control system, rural development measures, and cross-compliance.

The Committees' members welcomed the proposal and raised some constructive points that will be carefully assessed by the Commission in the coming weeks. They are encouraged to send additional comments to the Commission before the 11th July 2017 via the functional mailboxes of the Committees.

2) **AOB**

(a) Presentation of a pilot to support further integration and digitization of IACS across Europe

The Commission presented an indicative topic on an IACS related pilot to be funded under the Horizon 2020 Research and Innovation programme. It is to be noted that the information provided is at this stage only indicative pending the final adoption of the Work Programme 2018-2020. More information will be made public in October 2017.

(b) Vacancy notice for a Seconded National Expert (SNE), unit AGRI.DDG2.D3

The Commission informed the Committees' members that a vacancy notice was sent in June to Member States Permanent Representations to the EU regarding a position for a Seconded National Expert (SNE) in Directorate-General for Agriculture and Rural Development, Unit AGRI.DDG2.D.3. The deadline for sending the applications to the respective Permanent Representations to the EU in Brussels is 25/07/2017. Relative information has been made available on CIRCA BC.
