SUMMARY RECORD

Meeting of the COMMITTEE FOR DIRECT PAYMENTS 28 June 2017

Chair: Pierre Bascou

Delegations present: All Member States were present.

1. Budgetary ceilings for 2017:

Presentation and vote on a draft Commission Implementing Regulation (EU) .../... establishing budgetary ceilings for 2017 applicable to certain direct support schemes provided for in Regulation (EU) No 1307/2013 of the European Parliament and of the Council - DS/CDP/2017/01-Rev1 & DS/CDP/2017/02-Rev1.

The Commission's representative presented the draft regulation and explained that a new version of the annex to the act had been uploaded on CIRCA BC on 27/06/2017. The new version (DS/CDP/2017/01REV2-Annex) only contained changes as regards the amounts for Greece under the voluntary coupled support and the basic payment scheme. Everything else remained unchanged compared to the version uploaded on 14/06/2017 (DS/CDP/2017/01REV1-Annex). Amended figures were quoted. The implementing act will apply retroactively as from 1/1/2017.

The Committee voted unanimously in favour of the Commission draft regulation. Two delegations were not present.

2. Simplification Implementing Act DP (Hemp):

Vote on the draft Commission Implementing Regulation (EU) .../... of XXX amending Implementing Regulation (EU) No 809/2014 laying down rules for the application of Regulation (EU) No 1306/2013 of the European Parliament and of the Council with regard to the integrated administration and control system, rural development measures and cross compliance regarding the control measures for the cultivation of hemp - DS/CDP/2016/07-Rev1

The Commission's representative reminded the delegates about the content of the draft Commission Implementing Regulation that was already explained and discussed in September/October 2016 and could now be voted following the end of the scrutiny period for the connected Commission Delegated Regulation. Both Regulations will

be published in the Official Journal with one day difference (30 June for the Delegated Regulation, 1 July for the Implemented Regulation).

The Committee voted unanimously in favour of the Commission draft regulation. All delegations were present.

3. AOB

One delegate informed the Committee about the difficulties created by the drought situation affecting the country.
