

**Short Report of the 104<sup>th</sup> meeting of the  
Standing Committee on Organic Farming of 19-20 December 2011**

**President: Mme M.A. Benitez Salas, Mr J-F Hulot**

26 Member States were present or represented. Norway and Switzerland were present as observers.

**Section A – Opinion of the Committee**

**1. Draft Regulation amending Regulation (EC) No 889/2008 as regards documentary evidence and amending Regulation (EC) No 1235/2008 as regards the arrangements for imports of organic products from the United States of America**

The draft Commission Regulation received a favourable opinion by qualified majority: 333 votes in favour.

**Section B – Points for information and/or discussion**

**1. Commission Work Programme 2012**

The Commission highlighted the legal proposal mentioned amongst the forthcoming initiatives for 2013 in the Commission Working Programme of 2012 and presented an outline of the activities foreseen in 2012 and in 2013 concerning organic farming.

**2. Expert Group on Technical Advice for Organic Farming (EGTOP)**

The state of play of the works of the EGTOP including mandates on Poultry and Food sub-groups was presented.

**3. Implementing rules (Regulation (EC) No 889/2008)**

The state of play concerning organic feed was presented by the Commission, which confirmed its intention to bring forward a proposal containing, among other elements, an allowance of 5% of non-organic protein feed for non-herbivores applying as from 1<sup>st</sup> January 2012. Information was also provided concerning organic wine as well as concerning a draft RIPAC note on control issues. The delegations were also informed concerning the reports and other information that the Commission received according to the organic farming legislation.

**4. Review of Regulation (EC) No 882/2004 (official food and feed controls) – overview of the key issues and state of play**

A presentation was made concerning the key issues under review.

**5. Import regime (Regulation 1235/2008)**

Information on the applications by control bodies for the purpose of compliance in accordance with Art 32 of Regulation (EC) No 834/2007 was provided together with an update concerning applicant and recognised Third Countries under the equivalency regime.

#### **6. OFIS, irregularities and controls**

The Commission presented the state of play concerning irregularities on products coming from the EU as well as from Third Countries and a discussion took place concerning recent cases. The Commission also provided information concerning OFIS (Organic farming Information System).

#### **7. Miscellaneous**

At the request of a delegation, a discussion took place concerning improved detection levels of ethylene oxide.
