Report of the 134th meeting of the Committee on Organic Production of 21 September 2016

President: Diego CANGA FANO

26 Member States were present. Norway was present as observer.

Section A – Opinion of the Committee

- 1. Draft Commission Implementing Regulation (EU) amending Regulation (EC) No 1235/2008 as regards the electronic certificate of inspection for imported organic products and certain other elements, and Regulation (EC) No 889/2008 as regards the requirements for preserved or processed organic products and the transmission of information (D042122)**

The Commission presented the document in its final form. The Committee gave a favourable opinion on the draft Regulation (25 MS in favour and 1 MS abstained).

Section B – Points for information and/or discussion

- 1. Draft Commission Implementing Regulation (EU) amending Regulation (EC) No 1235/2008 laying down detailed rules for implementation of Council Regulation (EC) No 834/2007 as regards the arrangements for imports of organic products from third countries (amendment of annexes III and IV).**

The Commission presented the draft Regulation. Written comments are expected by 7 October.

The Commission informed about its position and a discussion followed.
- 2) Overview third countries
The Commission informed about on-going negotiations with third countries.

6. Reporting of operators to EUROSTAT

Some organic farming data to be reported from Member States to EUROSTAT for year 2015 is still missing. AT, DE, BE, PT & EL have been invited to send the relevant information as soon as possible to EUROSTAT.

A questionnaire concerning the harmonisation of methodology in data collection has been prepared by EUROSTAT. It will be sent soon to Member States, first for consultation and afterwards as official document to be used for the reporting.

7. EGTOP

The Com informed about the two subgroup still active :PPP III and Aquaculture C. Both reports will be published after com quality check.

The Com also informed about the new call for applications which is still in preparation.

8. Miscellaneous¹

- 1) NL: request of a temporary exceptional production rule

¹ Any subjects that the Member States wish to discuss under Point 'Miscellaneous' need to be submitted to the Commission and the other Member States at the latest one week before the meeting of the Committee on Organic Production.

2) ES: ozone use for irrigation water. The Com clarified that ozone is not authorised explicitly in organic Production, explained the legal status of the substance under the biocide regulation and request Spain to check the Egtop report as regards cleaning and désinfection.


FRANCE CEREVISAE AUTHIRITATION.
