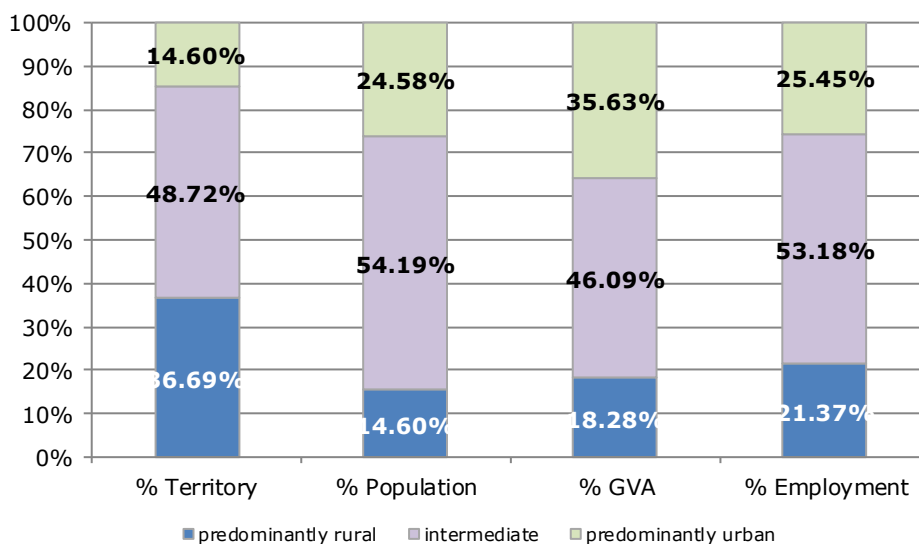

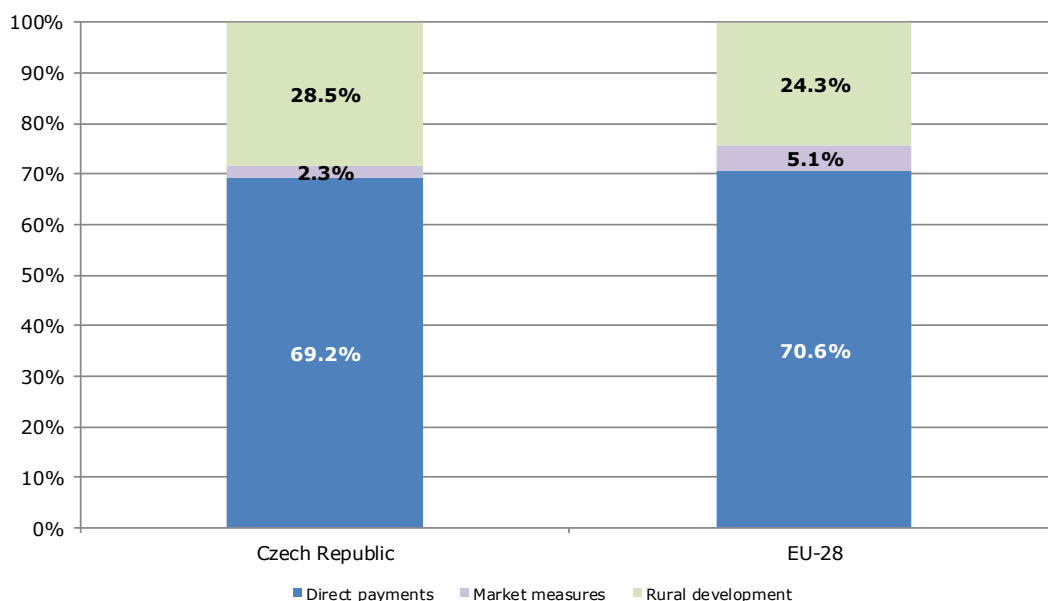

Distribution of CAP expenditure



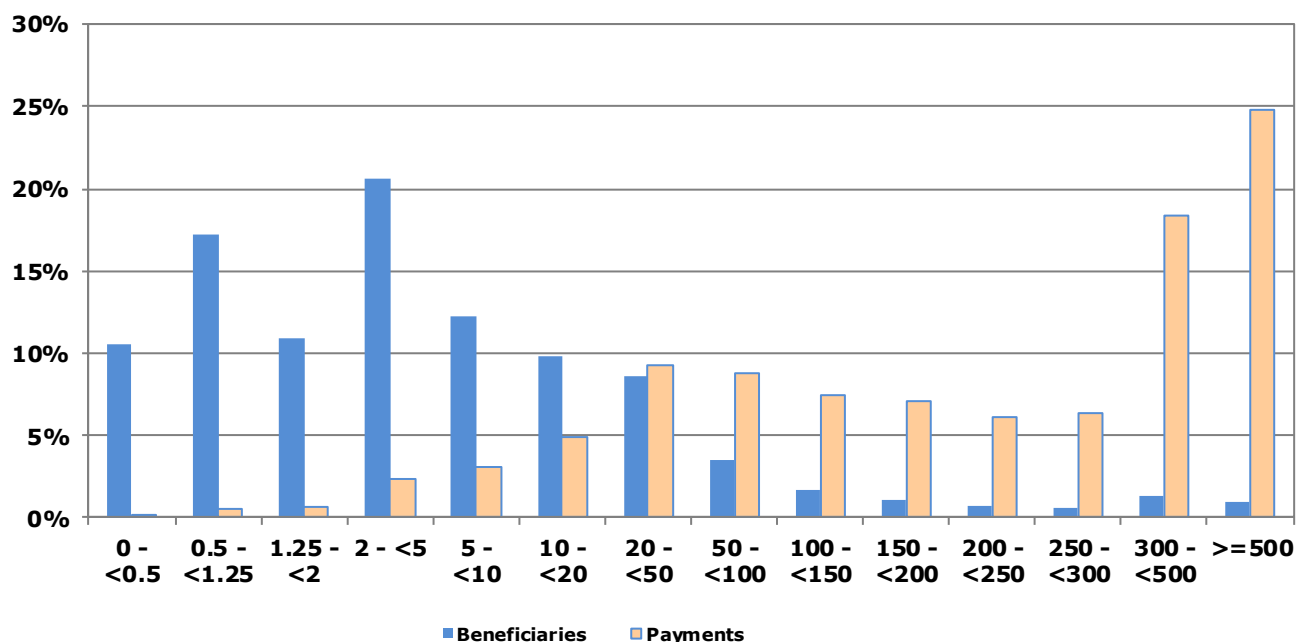

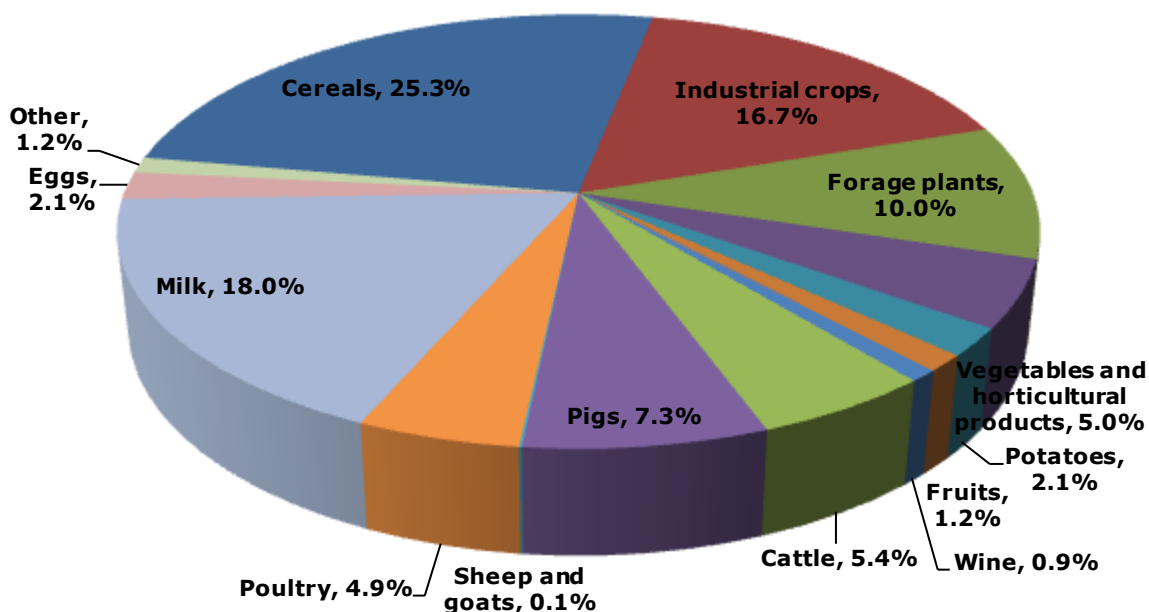

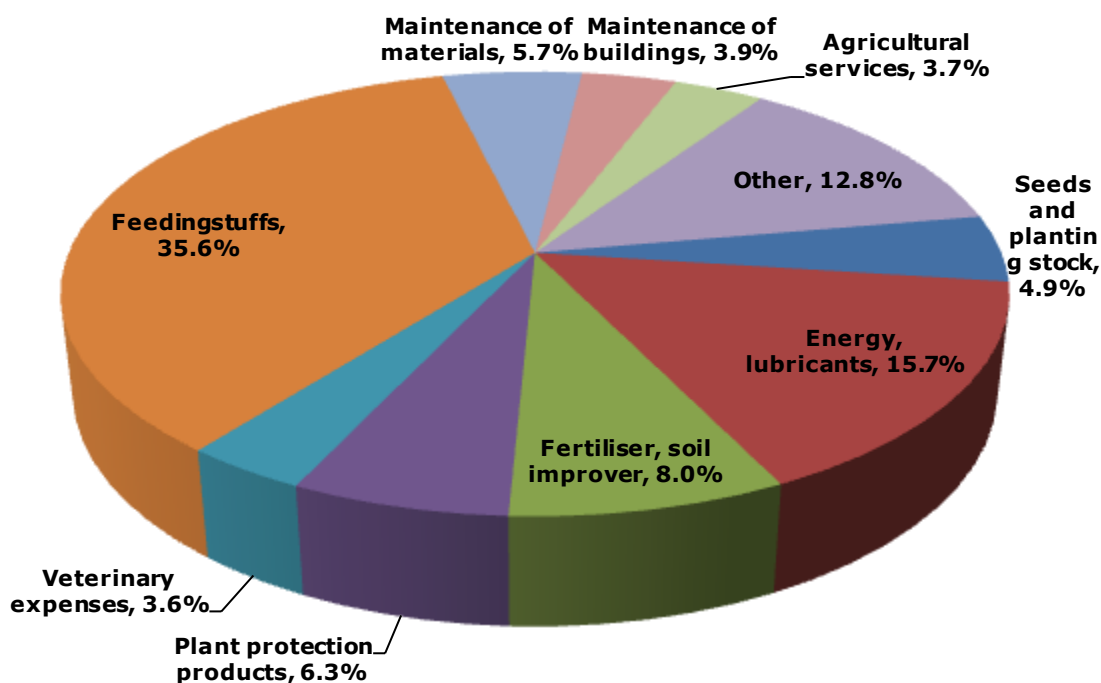

Output components (2015-2017 average)



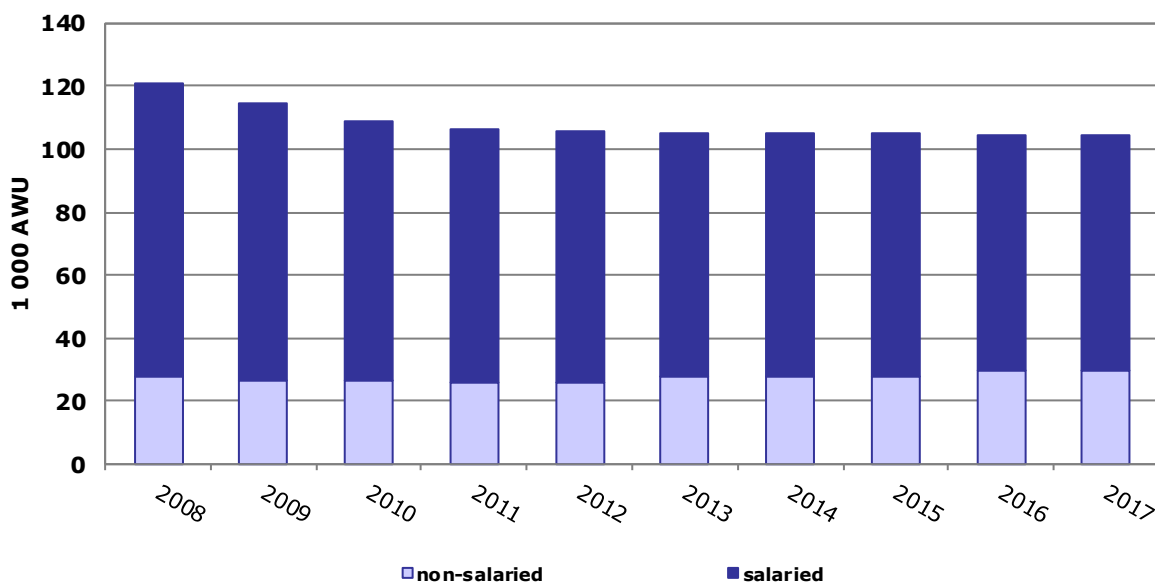

Intermediate consumption (2015-2017 average)



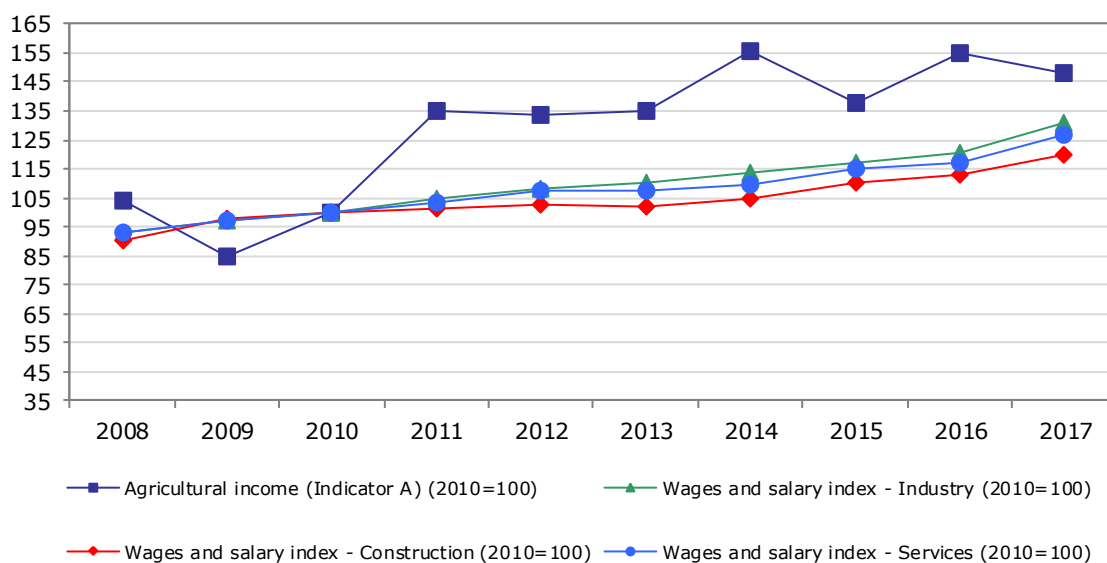

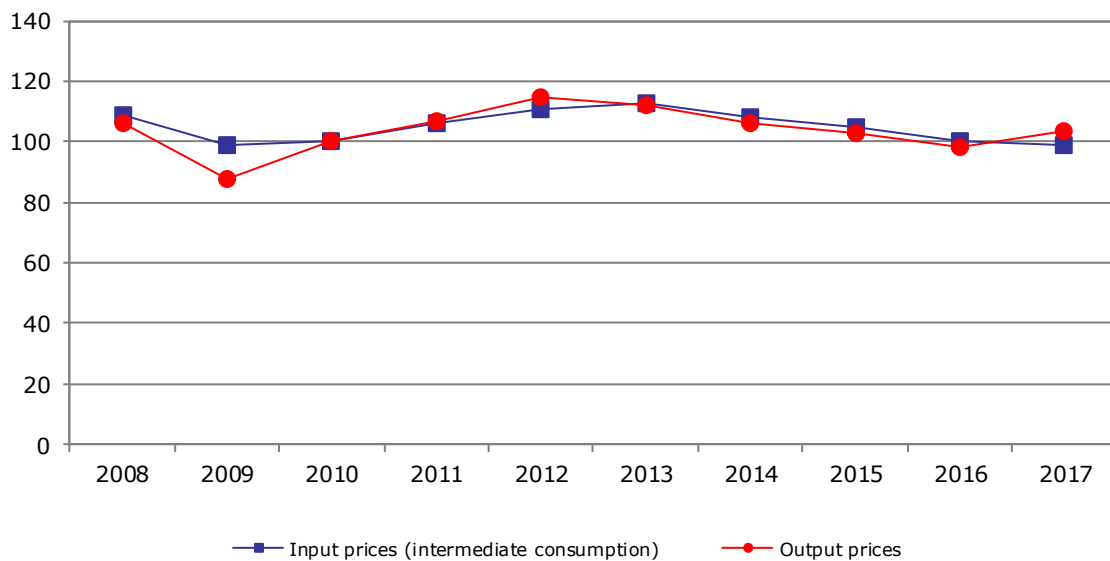
Evolution of agricultural income (*) compared to wages and salaries in other sectors of the economy

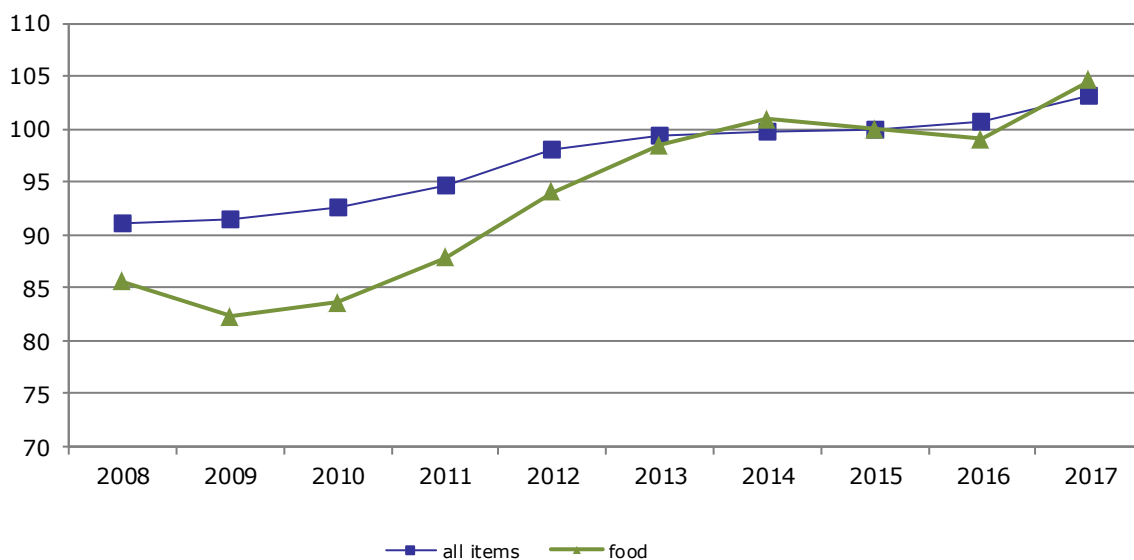

Evolution of agricultural input and output prices



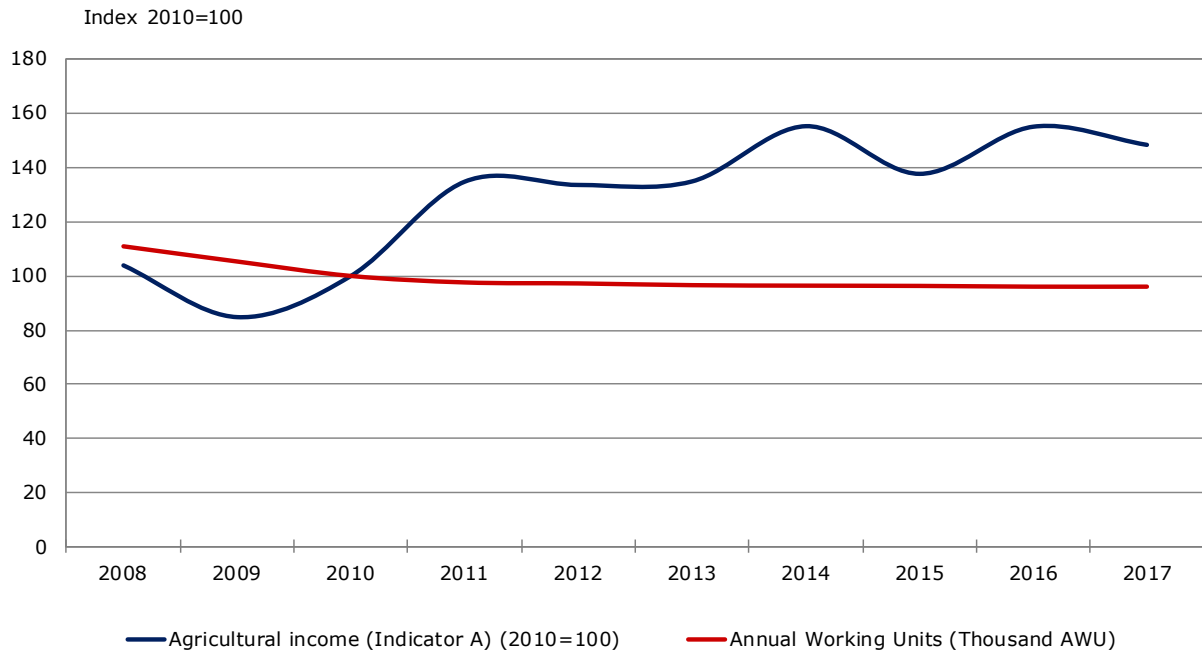

Farmers' income and labour development index (real terms)

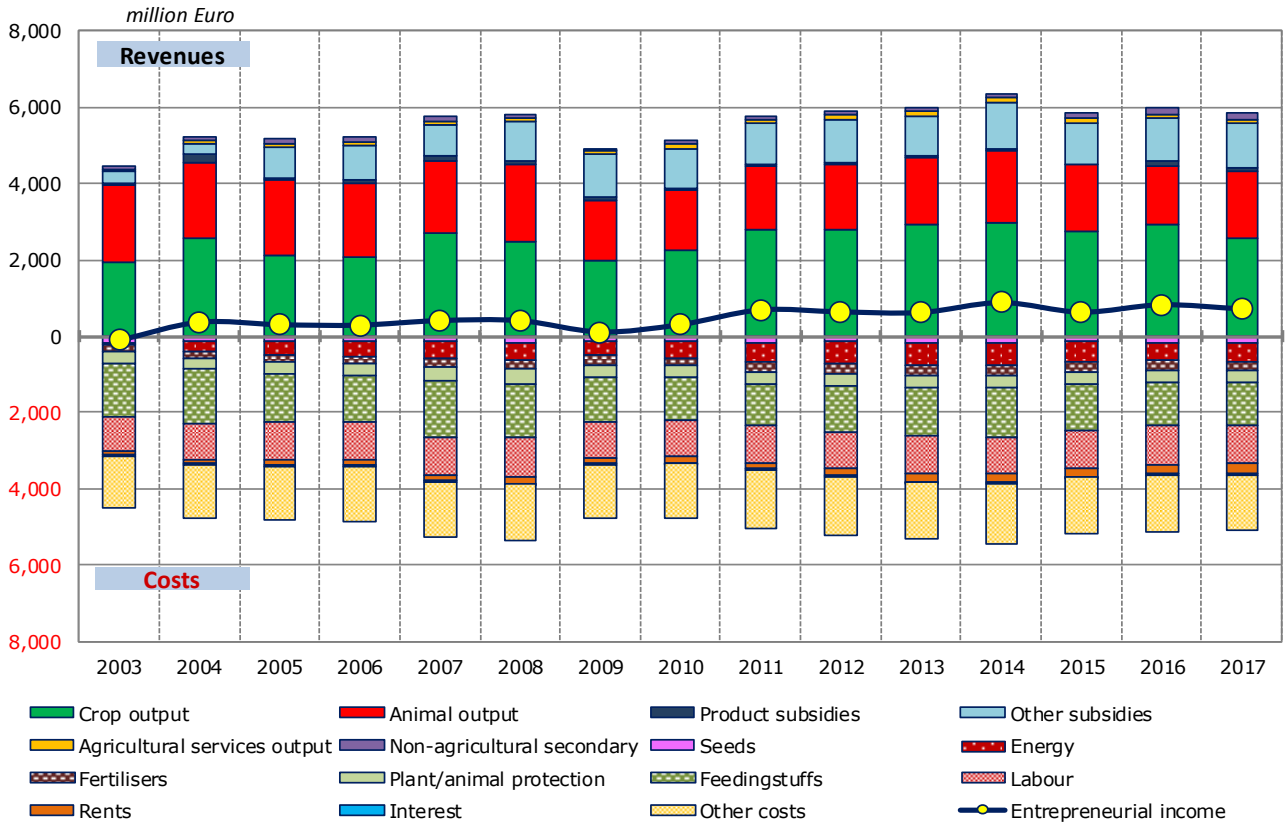

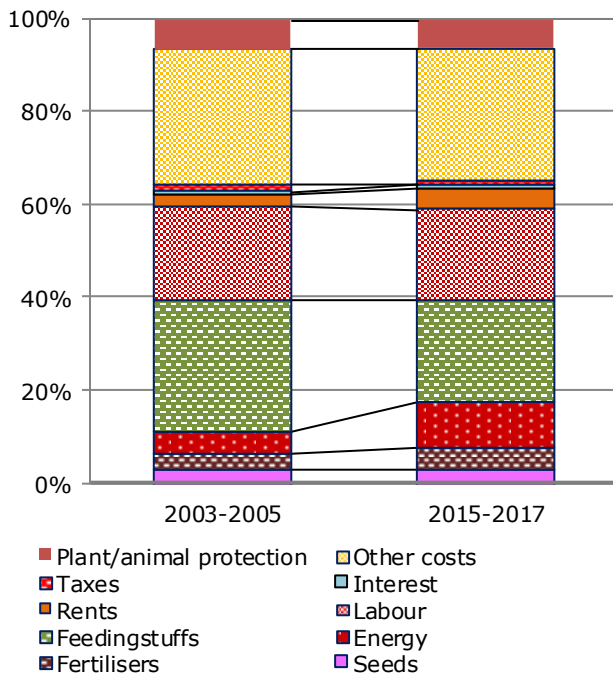

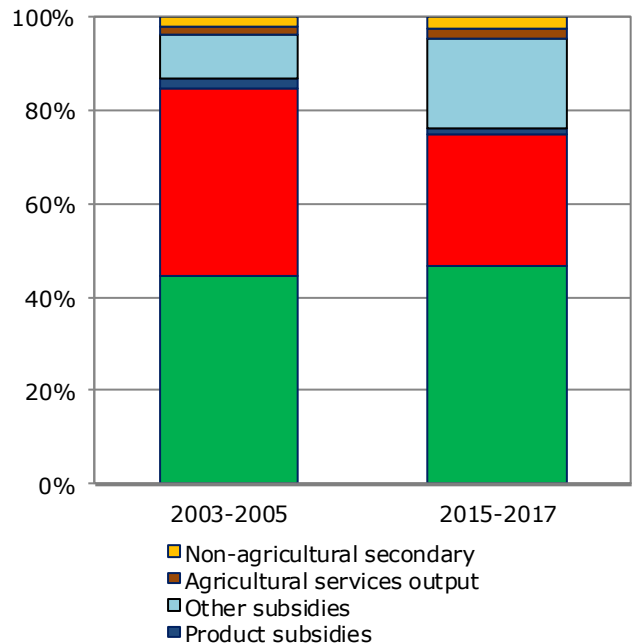
Agricultural income (real prices)

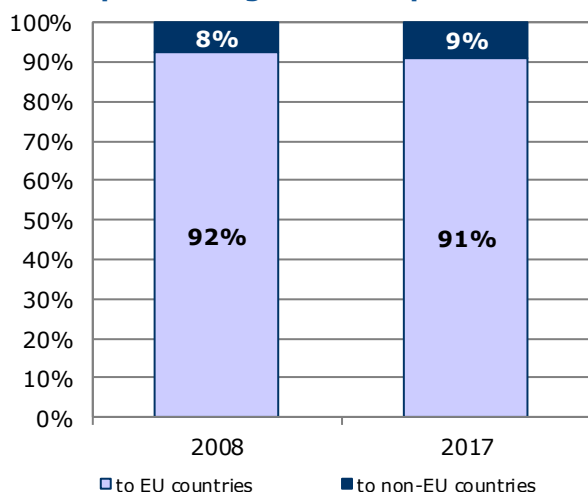

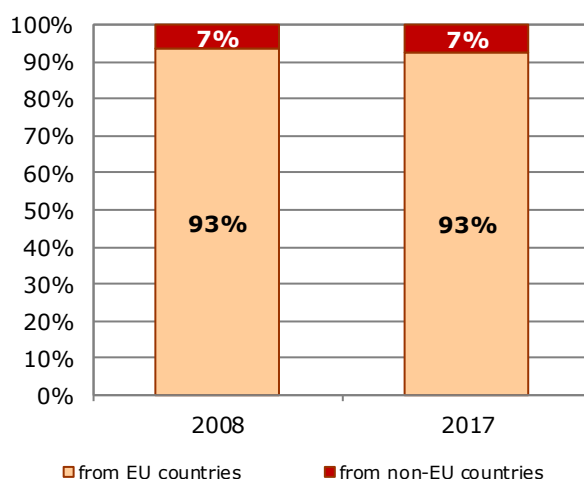

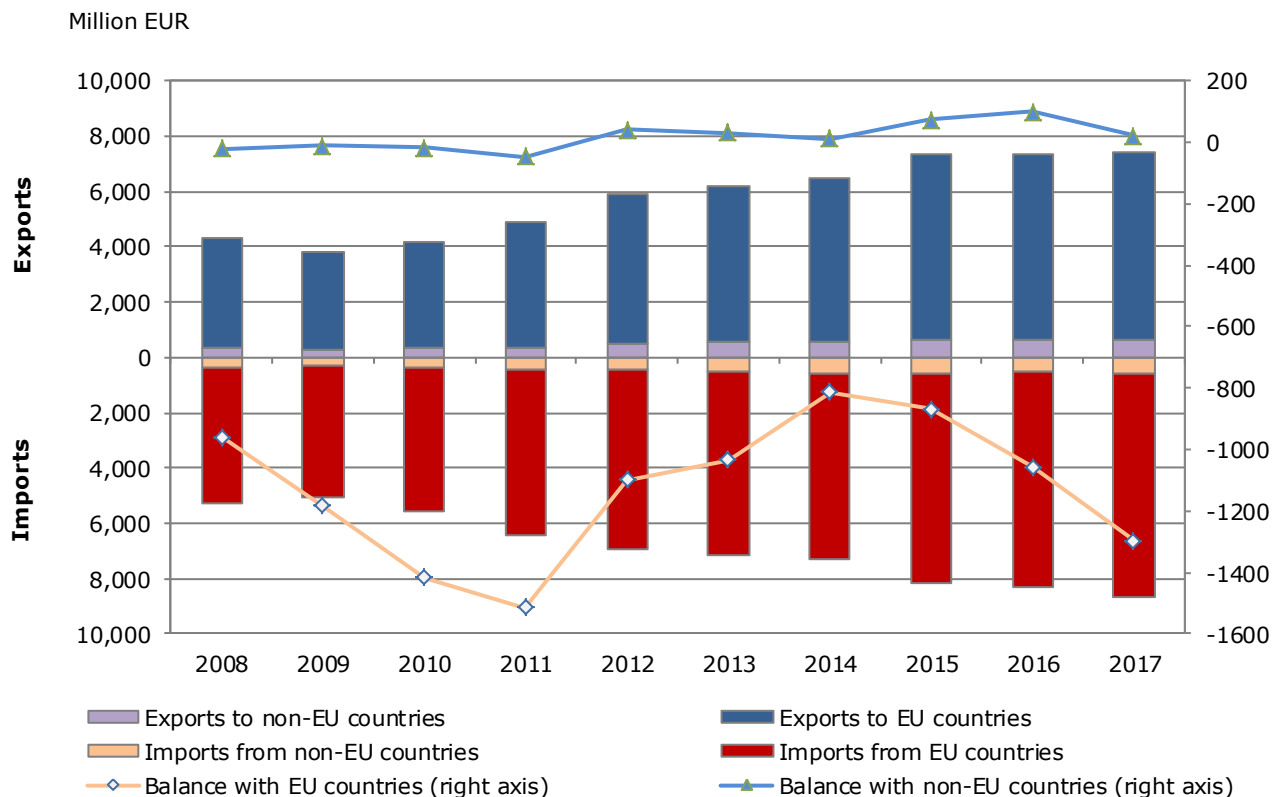
Exports of agricultural products



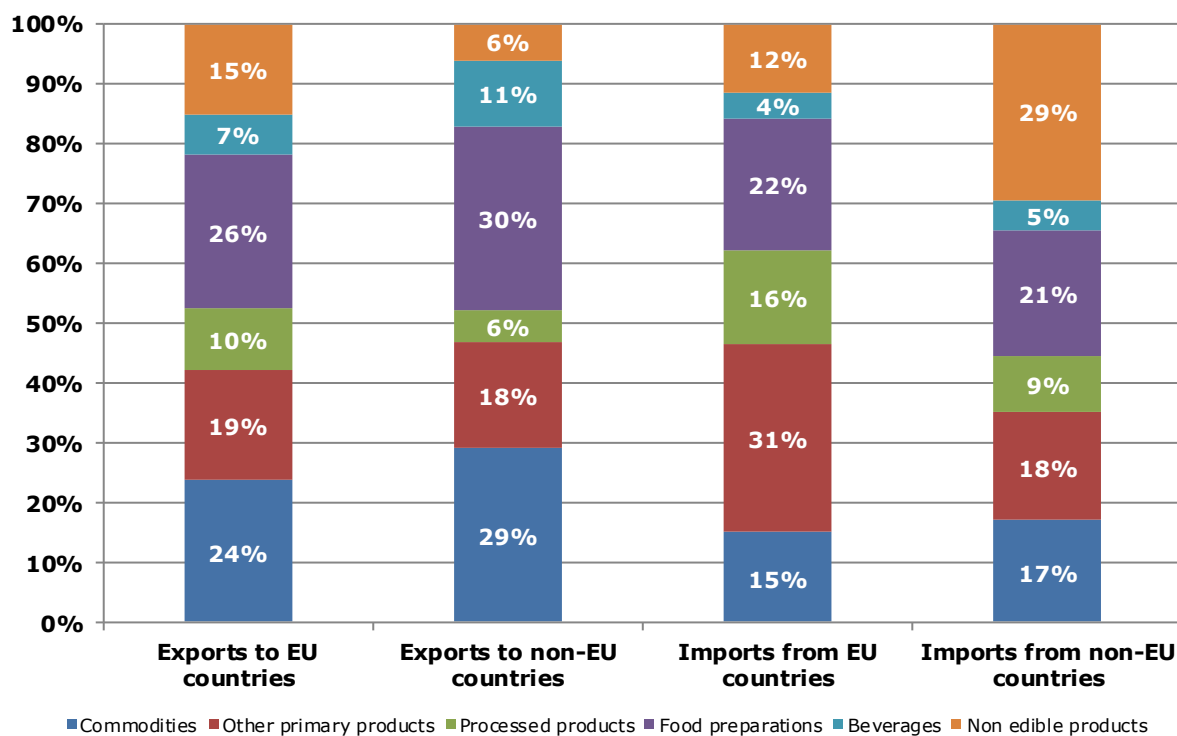
Imports of agricultural products

The sum of all the SO per hectare of crop and per head of livestock in a farm is a measure of its overall [economic size](#), expressed in euro.

(***) LSU = Livestock units. A LSU is equivalent to a dairy cow. The number of animals (heads) is converted into LSU using a set of coefficients reflecting the feed requirements of the different animal categories.
