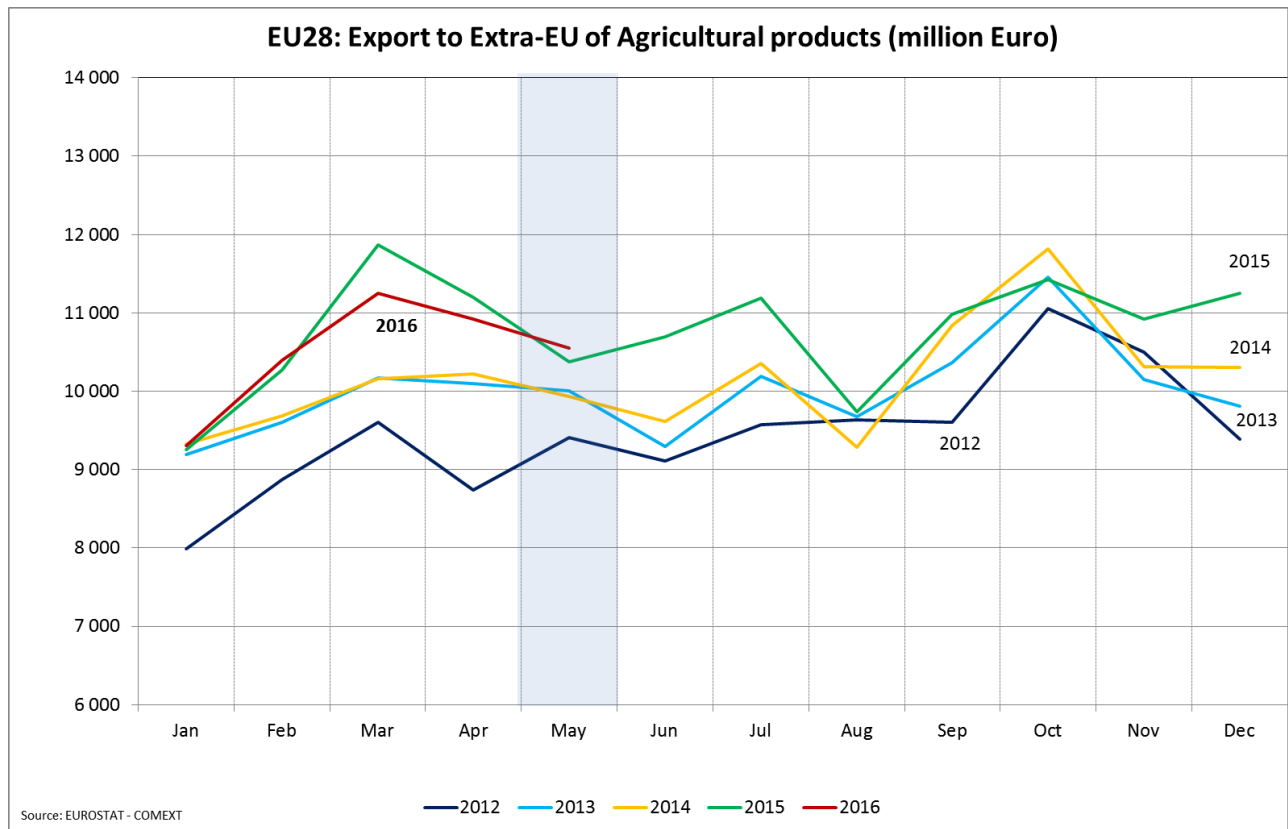


Monitoring EU Agri-Food Trade: Development until May 2016



May 2016 – EU pork exports increased by 80% in value terms

The monthly value of EU agri-food exports in May 2016 reached EUR 10.6 billion and, thus, slightly exceeded the export values in May of previous years.

EU agri-food exports in May 2016 registered a decline compared to April. However, this reflects to a general pattern in previous years.

Highest increases in monthly export values (May 2016 compared to May 2015) were recorded for the **USA** (EUR +126 million) and **Morocco** (EUR +95 million, mainly grains). Also, agri-food exports to Libya, Switzerland, China, Norway and Japan increased by EUR 30 million or more.

Most important reductions were in export values to Hong Kong, Saudi Arabia and Belarus.

The highest increases in monthly export values were achieved for **pork** (+80%), followed by wheat and olive oil.

On the other hand, monthly export values in April 2016 compared to April 2015 went down in particular for hides and skins, for other cereals and for milk powders.

In May 2016 agri-food **imports** to the EU slightly increased to a value of EUR 9.4 billion from EUR 9.3 billion in May 2015. The highest increase in monthly import values was from Ivory Coast and Ukraine.

12-month period: Most dynamic development in pig meat exports

For the 12-months period June 2015 to May 2016, EU agri-food exports reached a value of almost EUR 129 billion, corresponding to an increase by 2.6% in value terms compared to the same period one year ago.

Major gains were achieved in values of agri-food exports to the **USA** (EUR + 2.4 billion; +14%) and **China** (EUR +2.1 billion; +24%), followed by increases in exports to **Saudi Arabia** (EUR +0.6 billion). Agri-food exports to Switzerland, Australia and the United Arab Emirates, each increased by more than EUR 300 million in the twelve-months period. Exports to **Russia** further went down, from EUR 6.9 billion (June 2014 to May 2015) to EUR 5.6 billion (June 2015 to May 2016), i.e. a reduction in values by 20%.

Analysing the performance over the last twelve months per product category, export values increased in particular for **pig meat** (EUR +844 million; +22% compared to export values in the 12-months period one year ago, with an increase by EUR +216 million in May 2016 compared to May 2015), **wine** (EUR +630 million; +6%), **live animals** (EUR +512 million; +25%) and **spirits and liqueurs** (EUR +423 million; +4%). In relative terms, high increases in export values were also seen for eggs, butter and soya beans.

Similar to the development recorded for April, **wheat** (EUR -1.1 billion; -17%), **raw hides and skins** (EUR -825 million; -29%) and **milk powders** (EUR -691 million; -15%) lost most in export values over the last 12 months. Losses in export revenues were also noted for fresh fruit, infant food, sugar and poultry meat.

Major increases in agri-food imports from Ukraine

Agri-food imports from third countries in the period June 2015 to May 2016 came into the EU at a value of EUR 113 billion, i.e. an increase by 4.7% compared to the same period one year ago. The export surplus for the 12-months period stands at about EUR 16 billion.

Imports from the **Ukraine** showed the highest increase in values (EUR +780 million; +22%) in the 12-months period until May 2016, still increasing in the last month. Over the last 12 months, EU import values for agri-food products went up for **Argentina** went up by EUR 625 million (+12%), for **Ivory Coast** by EUR +609 million (+25%), **USA** (EUR +558 million; +5%) and **Turkey** (EUR +456 million; +10%), **Australia** (EUR +336 million; +19%) and **China** (EUR +238 million; +5%). Also some Latin American countries improved in agri-food exports to the EU, such as Peru, Colombia and Chile.

On the other hand, the value of agri-food imports from **Brazil** decreased by EUR 1.2 billion (-9%) and imports from other important suppliers, Indonesia and Canada also went down compared to the previous 12 months period.

Looking at imports per product category, the highest increase in values over the last 12 months was for **tropical fruit, nuts and spices** (EUR +1.7 billion; +14%). Imports also increased for oilseeds other than soya beans (EUR +667 million; +24.5%), cocoa beans (EUR +568 million; 18%), cereals other than wheat (EUR +463 million; +22%) and for fresh, chilled or dried fruit and vegetables.

On the other hand, import values decreased in particular for commodities such as **oilcakes** (EUR -784 million; -9%), unroasted coffee and tea in bulk (EUR -694 million; -6%), palm oil, palm kernel and coconut oil (EUR -261 million; -5%), soya beans (EUR -167 million; -3%), raw hides and skins (EUR -115 million) and casein (EUR -107 million), as well as for sugar (EUR -79 million).

Focus on: EU agri-food trade with Sub-Sahara Africa*

The EU is a net importer of agri-food products from Sub-Saharan countries. The net-surplus of exports from these countries to the EU alters between EUR 3 and 4 billion per year.

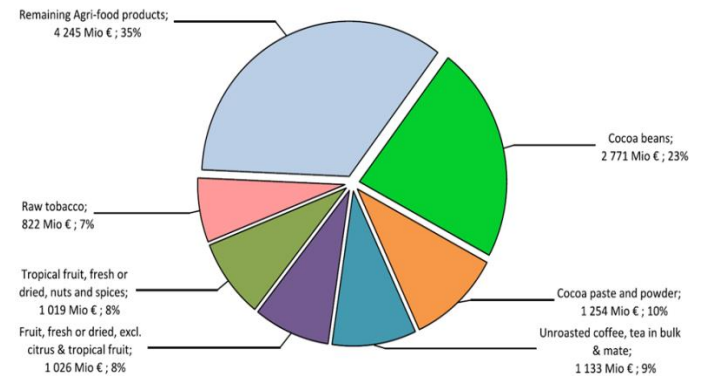
The value of EU agri-food imports from Sub Sahara Africa reached a total of EUR 12.3 billion, with main focus on commodities (cocoa beans, coffee), other primary products (fruit and vegetables) and non-food products (raw tobacco). The annual value of EU imports from these African countries is strongly determined by commodity prices for cocoa and coffee.

The most important origin countries for EU agri-food imports are Ivory Coast (EUR 2.7 billion; cocoa beans, paste and powder), South Africa (EUR 2.4 billion; fruits incl. citrus, wine) and Ghana (EUR 1.3 billion; cocoa beans, paste and powder). Other important trade partners are Kenya (flowers, coffee), Cameroon (cocoa and fruit) and Ethiopia (coffee, flowers). The EU is agri-food net importer with all these countries.

EU exports to Sub-Sahara Africa rather represent a mix of several agri-food categories, worth EUR 9.1 billion in 2015.

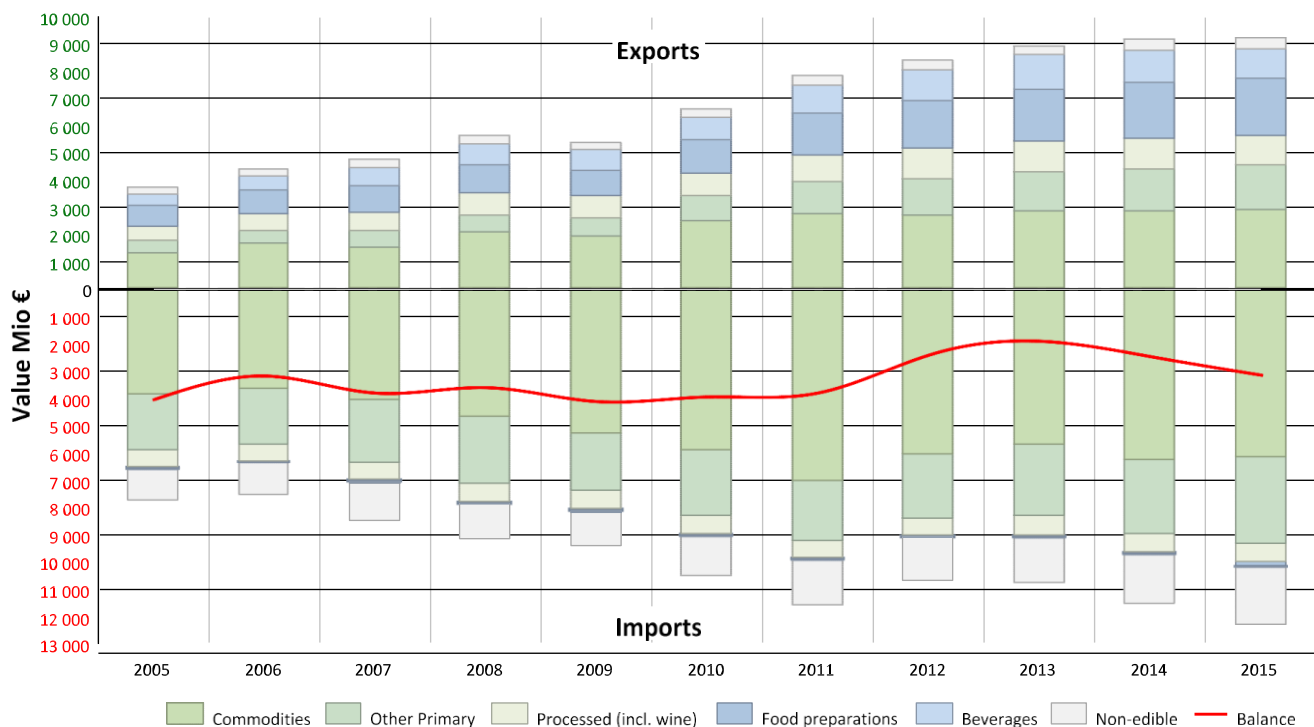
The most important export products are wheat, infant formula, poultry meat, milk powders as well as spirits and liqueurs.

EU imports from Sub-Sahara Africa, 2015



The main destination countries for EU agri-food exports are South Africa (EUR 1.7 billion), Nigeria (EUR 1.0 billion), followed by Ivory Coast, Senegal and Ghana. Exports to Nigeria showed a dynamic increase until 2014 and exports to Kenya and Ethiopia increased quite significantly in 2015.
