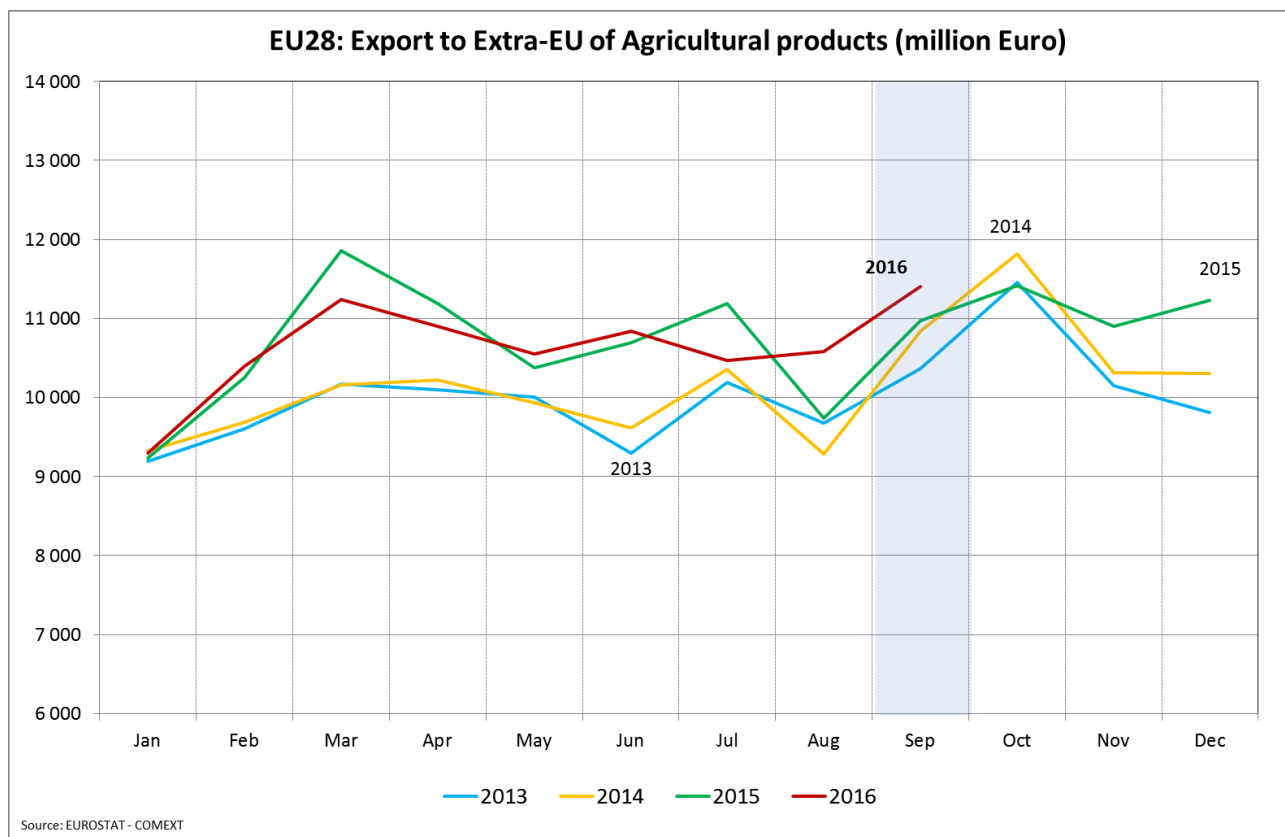


## Monitoring EU Agri-Food Trade: Development until September 2016



### September 2016 – new record in monthly EU agri-food export values

The monthly value of EU agri-food exports in August 2016 reached a record value of almost EUR 11.5 billion and, thus, exceeded the export values in September of previous years by about EUR 500 million.

Highest increases in monthly export values (September 2016 compared to September 2015) were recorded for the **USA** (EUR +129 million) and **Japan** (EUR +99 million). Also, agri-food exports to other **Asian countries** increased notably (S.Korea, Vietnam, India, Hong Kong).

Most important reductions were in export values to Algeria, Saudi Arabia and Turkey.

The highest increases in monthly export values compared to the previous year were achieved for **infant formula** (EUR +75 million), **wine** (EUR +72 million) and fresh vegetables (EUR +70 million), followed by olive oil, raw hides and skins, pork, edible meat offal and sugar.

On the other hand, monthly export values in September 2016 compared to September 2015 went down in particular for other cereals and milk powders.

In September 2016 agri-food **imports** to the EU slightly decreased to a value of EUR 9.0 billion from EUR 9.1 billion in September 2015. The highest increase in monthly import values was from Turkey, Uruguay and Argentina.

## 12-month period: Most dynamics in exports to USA and China

For the 12-months period October 2015 to September 2016, EU agri-food exports reached a value of EUR 129.9 billion, corresponding to an increase by 1.6% in value terms compared to the same period one year ago.

Major gains were achieved in values of agri-food exports to the **USA** (EUR + 1.7 billion; +9%) and **China** (EUR +1.3 billion; +13%), although exports to Hong Kong went down significantly. Increases were also recorded in agri-food exports to **Japan** (EUR +0.4 billion). Saudi Arabia, Israel, Switzerland, Norway and Australia, each increased by more than EUR 200 million in the twelve-months period. Exports to **Russia** further went down, from EUR 5.9 billion (Oct 2014 to Sept 2015) to EUR 5.5 billion (Oct 2015 to Sept 2016), i.e. a reduction in values by 7%. The value of exports to Algeria and Egypt also went down by around EUR 500 million each.

Analysing the EU export performance over the last twelve months per product category, export values increased in particular for **pig meat** (EUR +1.2 billion; +31% compared to export values in the 12-months period one year ago), **fresh vegetables** (EUR +480 million; +18%), meat offal, other meat and fat (EUR +419 million; +18%), olive oil (EUR +367 million; +16%) food preparations (EUR +295 million; +6%) and live animals (EUR +382 million; +17%). In relative terms, high increases in export values were also seen for butter (+30%).

Similar to the development recorded for previous periods, **raw hides and skins** (EUR -1.1 billion; -38%), **milk powders** (EUR -743 million; -17%) **wheat** (EUR -665 million; -10%) and **other cereals** (EUR -898 million; -30%) lost most in export values over the last 12 months.

## EU trade surplus in agri-food at EUR 17.6 billion over 12 months

Agri-food imports from third countries in the 12-months period October 2015 to September 2016 came into the EU at a value of EUR 112 billion, i.e. an increase by 0.9% compared to the same period one year ago. The export surplus for the 12-months period stands at more than EUR 17.6 billion.

Despite a reduction in the month of September 2016, imports from the **Ukraine** showed the highest increase in values (EUR +729 million; +20%) over the 12-months period. Over this period, EU import values for agri-food products also went up for **Ivory Coast** by EUR +524 million (+17%), Argentina (EUR +319 million; +6%), Peru (EUR +232 million; +13%) and Australia (EUR +196 million; +11%). Russia, Vietnam, Switzerland and several Latin American countries and South Africa improved in agri-food exports to the EU.

On the other hand, the value of agri-food imports from **Brazil** decreased by EUR 1.1 billion (-8%) and imports from other important suppliers, Indonesia, the USA, Malaysia and Turkey went down compared to the previous 12 months period.

Looking at imports per product category, the highest increase in values over the last 12 months was for **cocoa beans** (EUR +727 million; +18%). Imports also increased in particular for cereals other than wheat (EUR +718 million; +37%), tropical fruit (EUR +522 million; +4%), vegetable oils other than palm and olive oil (EUR +501 million; +28%) and oilseeds other than soya beans (EUR +490 million; 17%).

On the other hand, import values decreased in particular for commodities such as unroasted **oilcakes** (EUR -1.2 billion; -13%), **coffee** and tea in bulk (EUR -1.0 billion; -12%), palm oil, palm kernel and coconut oil (EUR -370 million; -7%), as well as for olive oil (EUR -346 million; -51%), and for wheat (EUR -267 million; -16%).
