Policy initiative on AMR

- *Will be comprised of:*
 - Proposal for a Council Recommendation on AMR
 - AMR provisions to be included in the chapeau Communication of revised EU pharmaceutical legislation package
 - Factsheets
 - ➔ To be adopted together as a package
 - ➔ Timeline: End of 2022

Policy initiative on AMR

- *The proposal for a Council Recommendation*
 - Aims at setting concrete objectives and activities to strengthen Member States action against AMR, mainly in the area of public health
 - Will help Member States to act in a coherent and coordinated manner
 - Could for example take the form of establishing common targets, common criteria for NAPs, core elements for antibiotic stewardship programmes, measures for surveillance systems, etc
- *Chapeau Communication of revised EU pharmaceutical legislation package*
 - Will include AMR provisions, especially with regard to the introduction of measures to restrict and optimise the use of antimicrobial medicines

Policy initiative on AMR

- *The initiative will be informed by:*
 - The outputs of the One Health Network subgroup led by France
 - The outputs of the Expert Panel on effective ways of investing in health
 - The outcomes of the Call for Evidence consultation
 - The outcomes of the future-proofing analysis, the AMR barriers study and the HERA preparatory actions
 - The results of the Eurobarometer on AMR
 - The recommendations of JAMRAI
 - The review of the NAPs

One Health Network subgroup

- It will provide technical expertise and opinions to the Commission on the setting concrete objectives and activities to strengthen EU and Member States action against antimicrobial resistance
- The objective is to develop conclusions summarising actions which Member States experts identify as relevant to consider for the policy initiative
- Consultative nature

One Health Network subgroup

- Chaired by the French representative(s) of the EU AMR One Health Network.
- Steering Committee composed of up to 3 Member States including France
- Steering Committee to advise on the methodology, prepare the discussions and review meetings' documents,
- All Member States' representatives of the AMR One Health Network will be invited to the subgroup meetings
- Member States should bring expertise in the three domains (human health, animal health and the environment)
