I am a associated Professor in Cardiology / Electrophysiology with focus in clinical and translational research, trained in the Heart Center at the University of Leipzig (DE), in Maastricht at MUMC+ (NL) and at Harvard University in Boston (MA, USA). My research has focused on improving methods of imaging in EP and elaborating the association between anatomy and clinical outcomes in patients with arrhythmias. My work helped develop novel anatomical indexes, computational approaches and risk stratification models for better patient selection, reduced defibrillator therapies and improved ablation outcomes.

I have participated as a sub-investigator in many trials (e.g. CABANA, EAST-AFNET, RESET-CRT, PVI-SHAM-AF, STEEER-AF, CMR-ICD-DZHK23) most of which are publicly funded. I have disclosed 3 studies that were industry-funded, in which I took over the role of PI. Some of my colleagues in my institution, provide consultancy advice to medical device companies, but I am not directly involved in the provision of such advice.

I am an active member of the European Society of Cardiology (ESC), the European Heart Rhythm Association (EHRA), the Heart Rhythm Society (HRS) and the American College of Cardiologists (ACC).
