The findings were confirmed by an independent analysis of United States (US) Food and Drug Administration (FDA) data (https:// www.ncbi.nlm.nih.gov/pubmed/21729796) in 2011 and by an official investigation of US Senate (https://www.ncbi. nlm.nih.gov/pubmed/23684264) in 2012.
