

EU-NEW ZEALAND TRADE AGREEMENT A TRADE DEAL FOR GREEN AND JUST GROWTH

June 2022



On 30 June 2022, the EU and New Zealand concluded negotiations for a Trade Agreement.

The deal opens great economic opportunities for companies, farmers, and consumers.

It includes unprecedented sustainability commitments, for example on respecting the Paris Climate Agreement and core labour standards, enforceable through trade sanctions as a last resort.

A DEAL ON TRADE AND BEYOND

- Deepens relations with the Indo-Pacific, one of the most economically dynamic regions in the world
- Cements ties with a like-minded ally at a time of intense geopolitical stress
- Builds resilience against the economic shocks of Russia's invasion of Ukraine







NEW BUSINESS OPPORTUNITIES FOR BUSINESSES BIG AND SMALL

MORE EU AGRI-FOOD EXPORTS AND DEFENDING EU FARMERS

- More opportunities to export EU agri-food produce through full tariff elimination on entry into force.
- The deal will protect the full list of close to 2000 EU wines and spirits names such as Prosecco, Polish Vodka, Rioja, Champagne and Tokaji.
- In addition, 163 of the most renowned EU food geographical indications, such as Parmigiano Reggiano, Asiago, Comté or Queso Manchego cheeses, Istarski pršut ham, Lübecker Marzipan, Elia Kalamatas olives will be protected in New Zealand.
