

Call for proposals 2010: results

Call for proposals “Training of national judges in EU competition law and co-operation between national judges – 2010”

The subjects were: promoting judicial cooperation between, and the training of, national judges in the context of the enforcement of the European competition rules, including Articles 101 and 102 of the TFEU, the State aid rules and Private enforcement of these provisions, with the aim of contributing to the development and implementation of European competition policy and cooperation measures within the European Union in order to ensure the consistency of EU.

The Commission received **18** proposals which were all eligible for evaluation.
