- 2. HPS is a US-based international investment firm that focuses on acquisitions and strategic financing or recapitalisation of companies that require financial assistance.
- 3. MDP is a US-based private equity investment firm that focuses on management buyouts, growth financing, financing for recapitalisation and acquisitions.
- 4. PFP is a small UK provider of risk management services operating as a Managing General Agent and specialising in fee protection cover, and also provides a range of related tax advisory services.
