SECTION 1.2

Description of the concentration

On 5 February 2019, the European Commission received a notification of the proposed concentration pursuant to article 4 of the EU Merger Regulation by which Strukturfonden HC15 AB, a portfolio company of Nalka Invest AB (both based in Sweden), will acquire shares in OneMed AB (based in Sweden) through Goldcup 17943 AB. Upon completion of the proposed concentration, Strukturfonden HC15 AB will indirectly own more than 90% of the shares in OneMed AB and hence acquire sole control of OneMed AB. The remaining shares will be owned by management.

Strukturfonden HC15 AB is a Swedish limited liability company, which sole purpose is to hold OneMed AB.

Nalka Invest AB is a Swedish investment company that invests in small and medium-sized companies mainly in the Nordics. Nalka Invest AB's aim is to invest in different industries and Nalka Invest AB has a diversified portfolio. Further information about Nalka Invest AB can be obtained at <https://www.nalka.com/>.

Nalka Invest AB is part of the Interogo group of companies that is ultimately owned by the Interogo Foundation (an enterprise foundation in Liechtenstein).
