**SECTION 1.2**

**Description of the concentration**

The notification relates to the acquisition, by way of purchase of shares, by Mirova S.A. (“**Mirova**”) of joint control, together with Prévoyance Dialogue du Crédit Agricole S.A. (“**Predica**”), over Infra Foch Topco SAS, the French holding company of the Indigo group (“**Indigo**”). The proposed transaction thus constitutes a concentration within the meaning of Articles 3(1)(b) and 3(4) of the EU Merger Regulation.

The undertakings concerned are:

1. Mirova is a *société anonyme* organised under the laws of France and headquartered in Paris (France). It is an asset management company which, through Natixis, is ultimately controlled by BPCE Groupe (Banque Populaire and Caisse d’Epargne) (“**BPCE**”). BPCE is a *société anonyme* organised under the laws of France and headquartered in Paris (France) and is active in a full range of banking and insurance activities.
2. Predica is a *société anonyme* organised under the laws of France and headquartered in Paris (France), a life and health insurance company belonging to Crédit Agricole Assurances, also a *société anonyme* organised under the laws of France and headquartered in Paris (France). Predica is France’s second biggest life insurer.
3. Infra Foch Topco, the holding company of Indigo is a *société par actions simplifiée* organised under the laws of France and headquartered in Puteaux (France). Indigo offers vehicle parking services, both off-street and on-street, as well as digital parking and individual mobility services in various European Union countries – mostly in France, Belgium, Spain and Luxembourg – as well as outside the European Union. It operates both for private and public actors.
