## **Description of the concentration**

On November 21, 2019, the European Commission received notification of a proposed concentration pursuant to Article 4 of Merger Notification by which Kennedy-Wilson Holdings, Inc. ("Kennedy Wilson") and AXA S.A. ("AXA") propose to collaborate through three fully functional joint venture vehicles (together the "JVs") to acquire, hold, and manage private rented accommodation, retail and office space in County Dublin, Ireland, within the meaning of Article 3(1)(b) and Article 3(4) of the Merger Regulation (the "Proposed Transaction"). The Proposed Transaction will be accomplished by the subscription of new shares in newly formed joint venture entities.
