SECTION 1.2

Description of the concentration

Through the notified transaction, the Spanish company BERAN CENTRAL EUROPE S.L.¹ ("BERAN") acquires 60% of the shares of the Belgian company ALCOMOTIVE NV² ("ALCOMOTIVE").

ALCOMOTIVE becomes a full-function joint venture controlled by both BERAN and ALCOPA.

ALCOMOTIVE is active in the automotive (4 wheels) and motorcycle (2 wheels) import and wholesale distribution in several countries of the EEA and Switzerland. Prior to the implementation of the notified transaction, its 2-wheels business will be carved out. ALCOMOTIVE is currently solely controlled by ALCOPA Group, an investment company active in a broad range of products and industries.

BERAN is in turn a joint venture between the Spanish company INTERNACIONAL DE AUTOMOCION BERGE S.L.³ (hereafter "INTERNATIONAL AUTO BERGE") and the Chilean company INVERSIONES EXTRANJERAS ELSAN SpA⁴ (hereafter "ELSAN").

ELSAN is a subsidiary of the Chilean company INMOBILIARIA ALGECIRAS LIMITADA⁵ (hereafter "**ALGECIRAS**"). ALGECIRAS' only activities in the EEA are its activities in joint ventures with BERGE AUTO, more concretely in Finland.

INTERNATIONAL AUTO BERGE is a subsidiary of BERGÉ AUTOMOCÍON S.L⁶ ("BERGE AUTO").
