- 1. On 05.06.2001 the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EEC) No 4064/89² by which the UK undertaking, Nomura International plc ("Nomura"), a wholly-owned subsidiary of The Nomura Securities Co. Ltd. ("NSCL"), acquires within the meaning of Article 3(1)(b) of the Council Regulation control of substantially all of the Le Meridien world-wide network of hotels through a structure of warrant-holding.
- 2. The business activities of the undertakings concerned are:

- Nomura: banking and financial services;

- NSCL: international investment banking;

- Le Meridien: hotels.

After examination of the notification, the Commission has concluded that the notified operation falls within the scope of Council Regulation (EEC) No. 4064/89 and of paragraph 4(c) of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EEC) No 4064/89³.
- 4. For the reasons set out in the Notice on a simplified procedure, the Commission has decided not to oppose the notified operation and to declare it compatible with the common market and with the EEA Agreement. This decision is adopted in application of Article 6(1)(b) of Council Regulation (EEC) No. 4064/89.
