1. On 21/01/2003, the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EEC) No 4064/89 by which the undertakings Burda Holding International GmbH ("Burda" - Germany) belonging to the Hubert Burda Media Group ("Burda Group" - Germany) and Holding di Partecipazioni Industriali SpA ("HPD" - Italy) acquire within the meaning of Article 3(1)(b) of the Council Regulation joint control of the undertaking Catherine Nemo Holding ("Catherine Nemo", France) by way of purchase of shares.

- 2. The business activities of the undertakings concerned are:
  - for Burda: Advertising and, printing, publication and distribution of consumer magazines, mainly in Germany.
  - for HDP: Advertising and, publication and distribution of books, magazines and newspapers, mainly in Italy.
  - for Catherine Nemo: Publication of the French magazines "Nouveau detective" and "Horoscope".
- 3. After examination of the notification, the Commission has concluded that the notified operation falls within the scope of Council Regulation (EEC) No. 4064/89 and of paragraph 4, subparagraphs a and c of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EEC) No 4064/89<sup>2</sup>.
- 4. For the reasons set out in the Notice on a simplified procedure, the Commission has decided not to oppose the notified operation and to declare it compatible with the common market and with the EEA Agreement. This decision is adopted in application of Article 6(1)(b) of Council Regulation (EEC) No. 4064/89.
