- On 19/01/2005, the Commission received notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No. 139/2004 by which the undertaking Gilde Buy-Out Fund II, ("Gilde", Netherlands) belonging to the Rabobank Group ("Rabobank", Netherlands), acquires within the meaning of Article 3(1)(b) of the Council Regulation control of the whole of the undertaking Bekaert Fencing NV ("Bekaert", Belgium) and its subsidiaries, by way purchase of shares.
- The business activities of the undertakings concerned are:
  - for Gilde: specialised investment fund
  - for Rabobank: banking and credit institution, financial services

- for Bekaert: manufacture and sale of steel wire-based fencing systems, wire-based industrial mesh, cable and wire.
- 3. After examination of the notification, the Commission has concluded that the notified operation falls within the scope of Council Regulation (EC) No. 139/2004 and of paragraph 5, subparagraph b of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No139/2004<sup>2</sup>.
- 4. For the reasons set out in the Notice on a simplified procedure, the Commission has decided not to oppose the notified operation and to declare it compatible with the common market and with the EEA Agreement. This decision is adopted in application of Article 6(1)(b) of Council Regulation (EC) No. 139/2004.
