(1) On 18/06/2007, the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No 139/2004¹ by which the undertaking Red & Black Lux S.À R.L. ("Red & Black", Luxembourg) controlled by Permira IV fund ("P IV"), which is ultimately controlled by Permira Holdings Limited ("PHL") acquires within the meaning of Article 3(1)(b) of the Council Regulation control of the whole of the Valentino Fashion Group S.p.A. ("Valentino Group", Italy) by way of purchase of shares.

- (2) The business activities of the undertakings concerned are:
 - For undertaking PHL: investment in companies at all stages of development and in different market sectors.
 - For undertaking Red & Black: special purpose vehicle established for the purposes of the transaction.
 - For undertaking Valentino Group: holding company of a group of undertakings mainly active in the design, production and wholesale distribution of luxury women's and men's clothes and related accessories.
- (3) After examination of the notification, the Commission has concluded that the notified operation falls within the scope of Council Regulation (EC) No. 139/2004 and of paragraph 5, subparagraphs c of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No. 139/20042.
- (4) For the reasons set out in the Notice on a simplified procedure, the Commission has decided not to oppose the notified operation and to declare it compatible with the common market and with the EEA Agreement. This decision is adopted in application of Article 6(1)(b) of Council Regulation (EC) No. 139/2004.
