- 1. On 04/11/2009, the Commission received notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No 139/2004 by which Fortis Insurance International N.V., controlled by Fortis SA/NV and Fortis NV, ("Fortis Insurance", the Netherlands/Belgium) and BNP Paribas Assurance, part of the BNP Paribas group, controlled by BNP Paribas SA ("BNP Paribas group", France) will acquire joint control over UBI Assicurazioni S.p.A. ("UBI Assicurazioni", Italy) by way of purchase of shares.
- 2. The business activities of the undertakings concerned are:
  - for the BNP Paribas group: banking and insurance activities;
  - for the Fortis Insurance: financial and insurance activities; and
  - for UBI Assicurazioni: non-life insurance activities in Italy.
- 3. After examination of the notification, the Commission has concluded that the notified operation falls within the scope of Council Regulation (EC) No 139/2004 and of paragraph

5(c) of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No  $139/2004^2$ .

This decision is adopted in application of Article 6(1)(b) of Council Regulation (EC) No 139/2004.
