**Subject: Case No COMP/M. 6741 - VIVENDI GROUP / N-C+ ENTITY  
Commission decision pursuant to Article 6(1)(b) of Council Regulation (EC) No 139/2004<sup>1</sup>**

1. On **26/10/2012**, the European Commission received notification of a proposed concentration pursuant to Article 4 of the Merger Regulation by which Canal+ Group SA, ("Canal+", France ultimately owned by Vivendi SA ("Vivendi")) acquires, within the meaning of Article 3(1)(b) of the Merger Regulation, control of the whole of N/C + Entity ("N/C+", Poland) by way of contract.
2. The business activities of the undertakings concerned are:
  - for Canal+: the production, distribution and marketing of television channels and services over all platforms,
  - for N/C+: the provision of pay-TV services via direct to home satellite in Poland.<sup>2</sup>

3. After examination of the notification, the European Commission has concluded that the notified operation falls within the scope of the Merger Regulation and of paragraph 5(d) of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No 139/2004<sup>3</sup>.
4. For the reasons set out in the Notice on a simplified procedure, the European Commission has decided not to oppose the notified operation and to declare it compatible with the internal market and with the EEA Agreement. This decision is adopted in application of Article 6(1)(b) of the Merger Regulation.
