Commission decision pursuant to Article 6(1)(b) of Council Regulation (EC)
No 139/2004¹ and Article 57 of the Agreement on the European Economic Area²

- 1. On 29 September 2016, the European Commission received notification of a proposed concentration pursuant to Article 4 of the Merger Regulation by which Mercedes-Benz Financial Services Nederland B.V., a wholly-owned subsidiary of Mercedes-Benz Nederland B.V., which is in turn a wholly-owned subsidiary of Daimler AG ("Daimler" of Germany) acquires within the meaning of Article 3(1)(b) of the Merger Regulation control of the whole of Athlon Car Lease International B.V. ("Athlon" of The Netherlands), by way of purchase of shares.³
- 2. The business activities of the undertakings concerned are:
 - for Daimler: development, manufacturing and sale of passenger cars and commercial vehicles, as well as provision of automotive financial services, including financing, leasing, insurance and fleet management;
 - for Athlon: car leasing and mobility services.

- 3. After examination of the notification, the European Commission has concluded that the notified operation falls within the scope of the Merger Regulation and of paragraph 6 of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No 139/2004.⁴
- 4. For the reasons set out in the Notice on a simplified procedure, the European Commission has decided not to oppose the notified operation and to declare it compatible with the internal market and with the EEA Agreement. This decision is adopted in application of Article 6(1)(b) of the Merger Regulation and Article 57 of the EEA Agreement.
