Subject: Case M.8525 – APAX PARTNERS / SAFETYKLEEN

Commission decision pursuant to Article 6(1)(b) of Council Regulation (EC) No 139/2004¹ and Article 57 of the Agreement on the European Economic Area²

Dear Sir or Madam,

- 1. On 1 June 2017, the European Commission received notification of a proposed concentration pursuant to Article of the Merger Regulation by which the undertaking Apax Partners LLP (United Kingom) acquires within the meaning of Article 3(1)(b) of the Merger Regulation control of the whole of the undertaking WP Safety-Kleen (Cayman) Limited ("SafetyKleen", Cayman Islands) by way of a purchase of shares.³
- 2. The business activities of the undertakings concerned are:
 - for Apax Partners LLP: provision of investment advisory services to private equity funds investing primarily in Europe in a range of industry sectors;
 - for SafetyKleen: provision of industrial parts cleaning machines, related cleaning products/solutions and spent detergent and solvent collection services.
- 3. After examination of the notification, the European Commission has concluded that the notified operation falls within the scope of the Merger Regulation and of paragraph 5(b) of

With effect from 1 December 2009, the Treaty on the Functioning of the European Union ('TFEU') has introduced certain changes, such as the replacement of 'Community' by 'Union' and 'common market' by 'internal market'. The terminology of the TFEU will be used throughout this decision.

For the reasons set out in the Notice on a simplified procedure, the European Commission has decided not to oppose the notified operation and to declare it compatible with the internal market and with the EEA Agreement. This decision is adopted in application of Article 6(1)(b) of the Merger Regulation and Article 57 of the EEA Agreement.
