> Commission decision pursuant to Article 6(1)(b) of Council Regulation (EC) No 139/2004 and Article 57 of the Agreement on the European Economic Area

Dear Sir or Madam,

- On 25 August 2017, the European Commission received notification of a proposed 1. concentration pursuant to Article 4 of the Merger Regulation by which certain investment funds advised and/or managed by Partners Group AG or its affiliates ('Partners Group', Switzerland) acquire within the meaning of Article 3(1)(b) of the Merger Regulation control of the whole of Civica Group Ltd ('Civica', United Kingdom) by way of a purchase of shares.³
- 2. The business activities of the undertakings concerned are:
 - for Partners Group: private markets investments.
 - for Civica: provision of software and related IT services
- 3. After examination of the notification, the European Commission has concluded that the notified operation falls within the scope of the Merger Regulation and of paragraph 5(c) of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No 139/2004.⁴
