**Subject: Case M.8890 - BNP PARIBAS / ABN AMRO BANK LUXEMBOURG  
Commission decision pursuant to Article 6(1)(b) of Council Regulation (EC)  
No 139/2004<sup>1</sup> and Article 57 of the Agreement on the European Economic Area<sup>2</sup>**

Dear Sir or Madam,

1. On 24 May 2018, the European Commission received notification of a proposed concentration pursuant to Article 4 of the Merger Regulation by which BNP Paribas ("BNPP", France) acquires within the meaning of Article 3(1)(b) of the Merger Regulation sole control of the whole of ABN AMRO Bank (Luxembourg) S.A. ("ABN AMRO Bank Luxembourg", Luxembourg) by way of purchase of shares.<sup>3</sup>
2. The business activities of the undertakings concerned are:
  - BNPP: active worldwide in retail banking and services as well as corporate and institutional banking,
  - ABN AMRO Bank Luxembourg: active in private banking.
3. After examination of the notification, the European Commission has concluded that the notified operation falls within the scope of the Merger Regulation and of paragraph 5(c) of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No 139/2004.<sup>4</sup>
4. For the reasons set out in the Notice on a simplified procedure, the European Commission has decided not to oppose the notified operation and to declare it compatible with the
