**Subject: Case M.9318 - COLISEE / ARMONEA
Commission decision pursuant to Article 6(1)(b) of Council Regulation (EC)
No 139/2004¹ and Article 57 of the Agreement on the European Economic Area²**

Dear Sir or Madam,

1. On 18 March 2019, the European Commission received notification of a proposed concentration pursuant to Article 4 of the Merger Regulation by which Financière Colisée S.A.S. (“Colisée”, France), controlled by Indigo International, a company controlled by IK VIII Limited, a fund operated by IK Investment Partners acquires within the meaning of Article 3(1)(b) of the Merger Regulation sole control of the whole of Armonea Group NV (“Armonea”, Belgium), currently controlled by Cofintra SA and Oaktree Invest NV through Stichting Administratiekantoor Armonea by way of purchase of shares.³
2. The business activities of the undertakings concerned are:
 - for Colisée: French nursing home operator, which manages nursing homes and provides homecare services;
 - for Armonea: a Belgian nursing home operator, which manages nursing homes, service flats, and residencies.
3. After examination of the notification, the European Commission has concluded that the notified operation falls within the scope of the Merger Regulation and of paragraph 5(c) of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No 139/2004.⁴

For the reasons set out in the Notice on a simplified procedure, the European Commission has decided not to oppose the notified operation and to declare it compatible with the internal market and with the EEA Agreement. This decision is adopted in application of Article 6(1)(b) of the Merger Regulation and Article 57 of the EEA Agreement.
