SECTION 1.2

Description of the concentration

On 10 September 2020, the European Commission received a notification pursuant to Article 3(1)(b) of the Council Regulation (EC) no. 139/2004, by which Public Sector Pension Investment Board (Canada) and Tishman Speyer Crown Equities 2007 L.L.C. (through Tishman Speyer Real Estate Venture VIII Master Fund S.C.A. SICAV/SIF (Luxembourg), with Tishman Speyer Europe S.à r.l. acting as its alternative investment fund manager) will acquire joint control of SCI Espace Lumière (France) (the "Target") within the meaning of Article 3(1)(b) of the EU Merger Regulation by purchase of shares.
