**Subject: Case M.9956 – DTC / CEPCON / HORNSEA ONE OFTO
Commission decision pursuant to Article 6(1)(b) of Council Regulation
(EC) No 139/2004^{1 2} and Article 57 of the Agreement on the European
Economic Area³**

Dear Sir or Madam,

1. On 9 December 2020, the European Commission received notification of a proposed concentration pursuant to Article 4 of the Merger Regulation by which the undertakings Diamond Transmission Corporation Limited (“DTC”, United Kingdom), ultimately controlled by Mitsubishi Corporation (“Mitsubishi”, Japan) and Chubu Electric Power Company Netherlands B.V. (“CEPCON”, the Netherlands), ultimately controlled by Chubu Electric Power Co., Inc (Japan), acquire within the meaning of Article 3(1)(b) of the Merger Regulation joint control over the whole of the undertaking Hornsea One OFTO (United Kingdom) by way of purchase of shares.⁴
2. The business activities of the undertakings concerned are:
 - for DTC: a holding company, integrating Mitsubishi’s investment activities in the transmission section. Mitsubishi is a global trading company with activities related to energy, metals, machinery, chemicals, food and general merchandise,
 - for CEPCON: holding Chubu’s overseas projects. Chubu is a multi-energy services group with activities related to electric utility and related enterprises, gas

supply and thermal storage brokerage, on-site energy businesses, overseas consulting and investment, real estate management services and IT services,

- for Hornsea One OFTO: owning and operating the transmission network for the Hornsea One offshore windfarm.
3. After examination of the notification, the European Commission has concluded that the notified operation falls within the scope of the Merger Regulation and of paragraph 5(b) of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No 139/2004.⁵
 4. For the reasons set out in the Notice on a simplified procedure, the European Commission has decided not to oppose the notified operation and to declare it compatible with the internal market and with the EEA Agreement. This decision is adopted in application of Article 6(1)(b) of the Merger Regulation and Article 57 of the EEA Agreement.
