Commission decision pursuant to Article 6(1)(b) of Council Regulation
(EC) No 139/2004¹ and Article 57 of the Agreement on the European
Economic Area²

Dear Sir or Madam,

- On 18 October 2021, the European Commission received notification of a proposed concentration pursuant to Article 4 of the Merger Regulation by which Apollo Management, L.P. ("Apollo", USA) intends to acquire within the meaning of Article 3(1)(b) of the Merger Regulation sole control of the whole of K1 Group S.A.S.U. ("K1 Group", France) by way of purchase of shares.³
- 2. The business activities of the undertakings concerned are:
 - for Apollo: portfolio investments,
 - for K1 Group: manufacture of chemicals and chemical products and manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms.
- 3. After examination of the notification, the European Commission has concluded that the notified operation falls within the scope of the Merger Regulation and of paragraph 5(b) of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No 139/2004.⁴
