Commission decision pursuant to Article 6(1)(b) of Council Regulation (EC) No 139/2004¹ and Article 57 of the Agreement on the European Economic Area²

Dear Sir or Madam,

- 1. On 5 August 2022, the European Commission received notification of a proposed concentration pursuant to Article 4 of the Merger Regulation, by which the undertaking Hestia Bidco Limited ('Hestia', Canada), controlled by Brookfield Asset Management Inc. ('Brookfield', Canada), intends to acquire, within the meaning of Article 3(1)(b), sole control over the whole of the undertaking HomeServe plc ('HomeServe', UK), by way of purchase of shares.³
- 2. The business activities of the undertakings concerned are the following:
 - Brookfield is a global asset manager which controls several portfolio companies, including Thermondo which is a German-based company specialized in the installation of heaters, ventilation and air conditioning ('HVAC') devices, as well as heat pumps,
 - Homeserve offers services for HVAC, and heat pump installation in homes. It also offers home maintenance and emergency assistance (principally relating to plumbing, heating and electrics), home insurance claims assistance as well as an online marketplace to help homeowners find local tradespeople on demand, to

help with home repairs and improvements. In the EU, HomeServe is active in Belgium, France, Germany, Italy, Malta, Portugal and Spain.

- 3. After examination of the notification, the European Commission has concluded that the notified operation falls within the scope of the Merger Regulation and of paragraph 5(c) of the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No 139/2004.⁴
- 4. For the reasons set out in the Notice on a simplified procedure, the European Commission has decided not to oppose the notified operation and to declare it compatible with the internal market and with the EEA Agreement. This decision is adopted in application of Article 6(1)(b) of the Merger Regulation and Article 57 of the EEA Agreement.
