Dear Sir or Madam,

- On 7 December 2023, the European Commission received notification of a proposed concentration pursuant to Article 4 of the Merger Regulation by which Eiffage Énergie Systèmes Participations SAS ('Eiffage', France) and Salvia Holding GmbH ('Salvia Holding', Germany) will acquire within the meaning of Article 3(1)(b) and 3(4) of the Merger Regulation joint control of Salvia Group GmbH ('Salvia Group', Germany). The concentration is accomplished by way of purchase of shares.<sup>3</sup>
- 2. The business activities of the undertakings concerned and the joint venture are the following:
  - Eiffage is a French construction and concessions group operating in the following main lines of business: (i) construction, (ii) infrastructure, (iii) concessions and (iv) energy systems,
  - Salvia Holding operates in Germany in the tiling, event planning and hotel/gym management sectors,

- Salvia Group provides in Germany technical services throughout the life cycle of buildings and facilities, from the planning phase to maintenance, notably the planning and installation of technical building equipment, related maintenance (technical facility management) and project management.
- 3. After examination of the notification, the European Commission has concluded that the notified operation falls within the scope of the Merger Regulation and of paragraph 5(d) of the Commission Notice on a simplified treatment for certain concentrations under Council Regulation (EC) No 139/2004.<sup>4</sup>
- 4. For the reasons set out in the Notice on a simplified procedure, the European Commission has decided not to oppose the notified operation and to declare it compatible with the internal market and with the EEA Agreement. This decision is adopted in application of Article 6(1)(b) of the Merger Regulation and Article 57 of the EEA Agreement.
