### **SECTION 4**

#### **Description of the concentration**

The proposed transaction concerns the acquisition of indirect joint control by two investment funds, TA Associates and Stirling Square Capital Partners, as well as Macquarie European Investment Holdings Limited (“**MEIHL**”) of Byggfakta Group Nordic Holdco AB, including each of their subsidiary undertakings (“**Byggfakta Group**” or the “**Target**”), (the “**Proposed Transaction**”). The Proposed Transaction thus constitutes a concentration under Article 3(1)(b) and Article 3(4) of Council Regulation (EC) 139/2004 (“**EUMR**”). Each of TA Associates, SSCP, Macquarie and the Byggfakta Group is a “**Party**”, together the “**Parties**”. The Proposed Transaction is to be effected by way of a share purchase pursuant to a public bid announced on 5 January 2024.
