Following introductory information from Ms Lenka Pítrová, Director of the Department of Strategies, Institutions and Analyses of the Office of the Government, the rapporteur's report by Senator Luděk Seřzig and after a debate

The Committee

I. Takes into account

the Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the Regions Commission Work Programme 2011;

II. Recommends

to the Presidency of the Conference of Community and European Affairs Committees of Parliaments of the European Union (COSAC) to continue with its practice of the coordinated testing of adherence to the principle of subsidiarity, and, in so doing, to consider adding the following EU legislative proposals to the list of documents to be focused on from this point of view:

- Strengthening economic governance-follow-up
- Legislative proposal on access to basic banking services
- Legislative initiative on Posting of Workers
- Revision of the Directive on Working Time (Directive 2003/88) (Carry-over 2010)
- Legislative proposal for a Common Consolidated Corporate Tax Base (CCCTB)
- Legal instrument on European Contract Law
- A new comprehensive legal framework for the protection of personal data in the EU (Carry-over 2010)
- Proposal for a revision of the Tobacco Products Directive 2001/37/EC concerning the manufacture, presentation and sale
- Proposal for a review of Directive 2006/24/EC (Data Retention)
- Regulation on a European Foundation
- EU framework for the approximation of sanctioning regimes in the financial sector
- Review of Directive concerning Institutions for Occupational Retirement Provision (IORP)
- Proposal for a Regulation on the conflicts of laws in matters concerning matrimonial property rights, including the question of jurisdiction and mutual recognition, and for Regulation on the property consequences of the separation of couples from other types of unions

- Revision of the Framework Decision on financial penalties
- Financial sector taxation
- Proposal on security scanners

IV. Authorises

the Committee Chairperson Senator Luděk Sefzig to submit this resolution to the President of the Senate and to the Presidency of the Conference of Community and European Affairs Committees of Parliaments of the European Union (COSAC).
