I would like to inform you about the opinion of the Committee for European Affairs of the Chamber of Deputies of the Parliament of the Czech Republic

the Proposal for a Directive of the European Parliament and of the Council amending Directive 2009/103/EC of the European Parliament and of the Council of 16 September 2009 relating to insurance against civil liability in respect of the use of motor vehicles, and the enforcement of the obligation to insure against such liability, COM(2018)336 final, Council Code 9365/18.

The respective document was included in the agenda of the 15<sup>th</sup> session of the Committee for European Affairs and was scrutinized on 5<sup>th</sup> September 2018. According to the Rules of Procedure of the Chamber of Deputies the Deputy Ministr of the Ministr of Finance was present at the session to introduce the preliminary Government's Framework Position.

After the hearing of the rapporteur's review and after the discussion the Committee has adopted the resolution No. 132 in the context of the Political Dialogue which is enclosed to this letter.

# 15th Session on 5 September 2018

the Proposal for a Directive of the European Parliament and of the Council amending Directive 2009/103/EC of the European Parliament and of the Council of 16 September 2009 relating to insurance against civil liability in respect of the use of motor vehicles, and the enforcement of the obligation to insure against such liability /COM(2018)336 final, Council Code 9365/18/

### **Conclusions of the Resolution:**

## Committee for European Affairs

- 1. generally **supports** the Proposal for a Directive of the European Parliament and of the Council amending Directive 2009/103/EC of the European Parliament and of the Council of 16 September 2009 relating to insurance against civil liability in respect of the use of motor vehicles, and the enforcement of the obligation to insure against such liability, COM(2018)336 final, Council Code 9365/18;
- 2. **supports** the Czech Government's Framework Position on the Proposal for a Directive from 26. 7.2018;
- 3. **welcomes** the fact that the Proposal for a Directive is dealing with unresolved issue with the implementation of the current text of the Directive of the European Parliament and of the Council 2009/103/EC of 16 September 2009 on civil liability insurance in respect of the use of motor vehicles and the control of the obligation to insure such a liability;
- 4. **considers**, however, that the definition of "vehicle operation" contained in the Proposal for a Directive should be clarified or adapted to the extent that it does not cover the use of vehicles on private land or the use of non-registrable vehicles;
- 5. **believes** that too broad definition of the term the vehicle operation may also cause the overlapping of responsibility for the operation of a motor vehicle with other civil liability regimes applicable in the event of an accident (e.g. liability for operating damage, general civil liability for damage);
- 6. **points out** that the transposition deadline is too short to transpose the Proposal for a Directive into the national legal orders of the Member States;
- 7. **authorizes** the Chairman of the Committee for European Affairs to forward this resolution to the President of the European Commission in the context of the Political Dialogue.
