Vážený pane předsedo,

Komise by ráda poděkovala Senátu Parlamentu České republiky za jeho stanovisko k problematice potravinového odpadu a bere na vědomí jeho podporu opatřením, jež nedávno k řešení této důležité otázky navrhla Sněmovna lordů a patnáct dalších parlamentních komor.

Řešení potravinového odpadu, jež znamená jak ekonomické, tak environmentální náklady, bude vyžadovat společné úsilí na mnoha úrovních. Komise proto v současné době pracuje na předložení ambiciózního balíčku opatření týkajících se oběhového hospodářství před koncem tohoto roku.

V příloze Senát nalezne kopii odpovědi Komise na společné stanovisko šestnácti vnitrostátních parlamentních komor.

Komise doufá, že objasnění, která poskytla ve své odpovědi, jsou dostatečná, a těší se na další pokračování vzájemného politického dialogu.

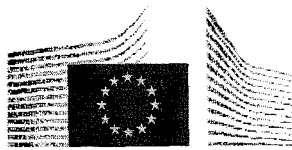

*The Commission would like to thank the 16 chambers that are signatories for their Opinion on food waste and has taken note of their invitation to the Commission to adopt a more strategic approach to the reduction of food waste in the EU when it comes forward with a circular economy package.*

*As the Commission stated at the July meeting of the Chairpersons of COSAC in Luxembourg, if Europe is to be successful in the future, it needs to move to a truly circular economy and to do so faster than its competitors elsewhere in the world. In order to facilitate this transition, we must ensure that we have the right legal environment in place and this is why the Commission is working hard on an ambitious circular economy package to be adopted later this year.*



*The Commission appreciates the chambers' highlighting of areas for policy development to support food waste reduction in the EU. The Commission indeed considers this as an integral part of the circular economy and one which requires action at all levels; national and local levels will also be key to ensuring that concrete progress is made.*


*The Commission has been working with stakeholders and Member States to identify the most appropriate actions at EU level to fight food waste<sup>1</sup> without compromising on food safety and building on actions taken by Member States. The Commission recognises that food waste is associated with impacts in terms of water and land resource use, biodiversity and greenhouse gas emissions, in addition to broader social and economic impacts. As the circular economy package is under preparation and has yet to be discussed by the College, it is not possible at this stage to comment on specific initiatives that may form part of it. We would like to reassure you, however, that the Commission will pay particular attention to your suggestions in developing its action plan including on food donation and on data collection and monitoring. The Commission will also take into account the comments it received from a wide range of stakeholders in the context of the public consultation which closed on 20 August 2015.*

*In closing, the Commission would again like to thank the chambers for their contribution on this important matter which it views as a clear demonstration of their readiness to contribute in a proactive and constructive manner to the policy debate at EU level. As you are aware, in the past year we have stepped up the Commission's engagement and dialogue with national Parliaments, both in terms of meetings and exchanges of view with parliamentary committees, and by a renewed commitment to the political dialogue on draft proposals. We plan to build on this further in 2016 with further steps to ensure that national Parliaments have a strong voice in European policy-making, as was set out in the Commission Work Programme for 2016.*
