The European Commission would like to thank the relevant Committees of the Danish Parliament for its contribution of 18 January 2010 to the Green Paper on obtaining evidence in criminal matters from one of the Member State to another and securing its admissibility {COM(2009)624}, adopted on 11 November 2009.

The consultation launched by the Green Paper forms part of an impact assessment that the Commission is currently conducting with the purpose of identifying the best way to proceed in order to improve cooperation on obtaining evidence in criminal matters. Since this impact assessment has not yet been concluded, the Commission cannot at this stage provide any detailed comments to the reply from the Danish Parliament.

However, the Commission has taken note of the different views expressed in the three minority opinions concerning the general objective which is to replace the existing legal regime on obtaining evidence in criminal matters by a single instrument based on the principle of mutual recognition and to introduce common standards for gathering such evidence.

The Commission will carefully analyse the reply from the Danish Parliament and as far as possible take it into account when analysing the possible ways to proceed in order to improve cooperation on obtaining evidence in criminal matters.
