CONCERNING THE PRIORITIES OF THE SEIMAS OF THE REPUBLIC OF LITHUANIA IN ACCORDANCE WITH THE WORK PROGRAMME 2015 OF THE EUROPEAN COMMISSION

Dear Mr President,

The Seimas of the Republic of Lithuania has very thoroughly examined the Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the Regions "Commission Work Programme 2015. A New Start" COM(2016) 910 (hereinafter referred to as the Commission Work Programme).

After having discussed the Commission Work Programme and taken account of the New Initiatives and REFIT Actions, the specialised committees of the Seimas of the Republic of Lithuania identified the initiatives and actions that are relevant and very relevant to Lithuania. Having summed up the conclusions of the specialised committees of the Seimas of the Republic of Lithuania at their joint meeting, the Committee on European Affairs of the Seimas of the Republic of Lithuania and the Committee on Foreign Affairs of the Seimas of the Republic of Lithuania (hereinafter referred to as the Committees) approved the Seimas priorities in accordance with the Commission Work Programme.

I would like to inform you that when approving the Seimas priorities in accordance with the Commission Work Programme on 23 January 2015, the Committees *emphasised* the need for strengthening inter-institutional cooperation at the European Union level in order to ensure better and more efficient implementation of initiatives within the framework of the overall EU policy agenda for the next five years. In this context, welcoming the conclusions on multiannual programming and legislative planning endorsed by the General Affairs Council of the European Union on 17 December 2014, the Committees *expect* that the cooperation among the European Commission, the Council and the European Parliament will be further strengthened in order to ensure both a more rapid and efficient legislative process and greater benefits for all EU citizens. The Committees *express their belief* that strengthened inter-institutional dialogue when drafting the EU annual and multi-annual programmes will allow not only to coordinate the priorities more efficiently, but will also promote more active and effective involvement of national Parliaments, which play a crucial role in consolidating the link between European citizens and European policy

making, in the EU legislative planning process. When considering the Seimas priorities in accordance with the Commission Work Programme, the Committees draw attention to the fact that the initiatives laid down in the Commission Work Programme should contribute to achieving the goals of the social dimension of the Europe 2020 strategy and at the same time ensure reduction of social exclusion and poverty in the EU.
