## CONCERNING THE PRIORITIES OF THE SEIMAS OF THE REPUBLIC OF LITHUANIA IN ACCORDANCE WITH THE COMMISSION WORK PROGRAMME 2016

Dear Mr President,

The Seimas of the Republic of Lithuania has analysed very thoroughly the Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the Regions on the Commission Work Programme 2016 "No time for business as usual" (COM(2015) 610 final) (hereinafter referred to as the Commission Work Programme).

Having discussed the Commission Work Programme and assessed the planned new initiatives and REFIT actions, the specialised committees of the Seimas of the Republic of Lithuania have outlined relevant and very relevant initiatives for Lithuania. In a joint meeting after summarising the conclusions of the specialised committees of the Seimas of the Republic of Lithuania, the Committee on European Affairs and the Committee on Foreign Affairs of the Seimas of the Republic of Lithuania (hereinafter referred to as the Committees) have approved the priorities of the Seimas in accordance with the Commission Work Programme 2016.

Please be informed that the Committees discussed the Commission Work Programme on 16 December 2015 and welcomed the Commission's objective to enhance the political dialogue with national Parliaments, as it was stressed in your letters of intent of 18 December 2014 and of 8 September 2015. The Committees underscore the importance of the interinstitutional agreement on better regulation and the role of national Parliaments in the EU legislative process. The list of

priorities of the Seimas in accordance with the Commission Work Programme indicates as very relevant those proposals which, while being the main policy factors that ensure the wellbeing of citizens, may have a significant impact on the security and social inclusion of the Lithuanian citizens and the economic growth and strengthening of competitiveness of the country. I hereby attach the priorities of the Seimas of the Republic of Lithuania in accordance with the Commission Work Programme 2016.
