*The Commission appreciates the Assembleia da República's conclusion that the objectives of these proposals, which are part of the Recovery Package, cannot be sufficiently achieved by Member States and that action at the EU level is necessary.*

*The Commission welcomes the unanimous agreement reached by the European Council on 21 July 2020 on the Multiannual Financial Framework 2021-2027 and the Recovery Package. This historic agreement endorses the approach put forward by the Commission, is proof of Europe's ability to act, to show solidarity in times of crisis, and takes the opportunity to keep the European promise of a better future. It is important that National Parliaments keep engaging with their governments to help ensure that the Recovery Package is adopted quickly. National Parliaments will also have an essential direct role to play when the decision on own resources has to be approved, after its adoption by the Council, by each Member State in accordance with its constitutional requirements. The Commission is confident that the Assembleia da República will do its utmost to facilitate the swift entry into force of this decision and of the Recovery Package, which are essential for creating a new dynamism in our economies and societies to overcome the COVID-19 crisis.*

*In the agreement reached on July 21, the members of the European Council have not retained the Solvency Support Instrument.*

*The Commission believes that the political dialogue with national Parliaments is essential for linking the Institutions and the citizens of the European Union, and looks forward to continuing it with the Assembleia da República in the future.*
