## Electronic business and invoicing in public sector

- Work on promoting electronic business with public sector started already in the late 1990s
  - Single Face To Industry
- Electronic catalogues (price lists), orders and invoices
- All adoption on voluntary basis initially
- Slow start but some success stories



### Transposition of the Directive

- Law will come into force on April 1
- Suppliers will be required to send electronic invoices to public sector
- Penalty can be imposed if supplier continues to send paper
- The European Standard (PEPPOL BIS Billing 3 implementation) required unless specific bilateral agreements are in place

#### Current situation

- Support for elnvoicing
  - All governmental authorities
  - About 95% of municipalities and regions
  - Publicly owned companies not known
- PEPPOL must be supported by governmental authorities since 2018
- PEPPOL will be required from October 1 for the rest of the public sector
  - Municipalities and regions (currently 76%)
  - Publicly owned companies (not measured)
