## 1. Introduction

This document is intended for a technical audience consisting of developers, administrators and those requiring detailed technical information on how to configure, build and deploy the eIDAS-Node application.

The purpose of this document is to facilitate migration from eIDAS-Node v1.4.4 to eIDAS-Node v1.4.5.

#### **1.1. Document structure**

This document is divided into the following sections:

Chapter 1 - Introduction: this section.

Chapter 2 — *Prerequisites*: Identifies any prerequisites that are required before migrating your eIDAS-Node to version 1.4.5.

Chapter 3 — Changes: Contains detailed information about the changes that should be taken into consideration when migrating to eIDAS-Node version 1.4.5.

#### **1.2.** Document aims

The main aim of this document is to provide information on all the changes requiring your action when migrating to eIDAS-Node version 1.4.5, including:

- configuration changes; and
- changes to common code.

## 2. Prerequisites

Before starting your migration to eIDAS-Node version 1.4.5 you should have:

already implemented eIDAS-Node version 1.4.4; downloaded the eIDAS-Node v1.4.5 Integration Package; and downloaded the latest documentation.

## 3. Changes

#### **3.1.** Summary of changes

In eIDAS-Node version 1.4.5 there are several changes that will affect your installation.

#### 3.2. Upgrade of Bouncycastle dependency to version 1.60

Bouncycastle dependency was upgraded from v1.52 to v1.60 due to reported CVEs in this dependency. The latest Bouncycastle version 1.61 is not used due to a jar signature validation issue in Jboss7 related to the bcprov-jdk15on-161.jar.

The following vulnerabilities were cleared by this upgrade:

#### **3.2.1.** Code changes

The EIDAS-Parent/pom.xml was changed, in the following property:

```
<bouncycastle.version>1.60</bouncycastle.version>
```

which previously had the value of 1.52 and it is now 1.60.

#### 3.2.2. Configuration changes

In AdditionalFiles/JBOSS7/org/bouncycastle/main:

- a file named bcprov-jdk15on-1.52.jar was replaced by a signed version of bcprovjdk15on-1.60.jar from <u>https://www.bouncycastle.org/download/bcprov-jdk15on-</u> <u>160.jar</u> (160 was renamed 1.60);
- the module.xml was changed so that now it holds <resource-root path="bcprovjdk15on-1.60.jar"/>

## **3.3. Upgrade Bootstrap dependency to version 4.3.1**

Bootstrap dependency was upgraded from v3.3.5 to the latest available v4.3.1 due to reported CVEs related to this dependency.

The following vulnerabilities were cleared by this upgrade:

#### 3.3.1. Code changes

The following files content:

- EIDAS-Node/src/main/webapp/resource/skin0/css/bootstrap.min.css
- EIDAS-Node/src/main/webapp/resource/skin0/js/bootstrap.min.js

were replaced by the content of Bootstrap version 4.3.1

#### **3.4. Other fixes/improvements**

#### 3.4.1. Updated Eidas Application Identifier value

The eidas.application.identifier property value was updated to version CEF:eIDAS-ref:1.4.5 for EidasNode (eidas.xml), SP (sp.properties) and IdP (idp.properties).
