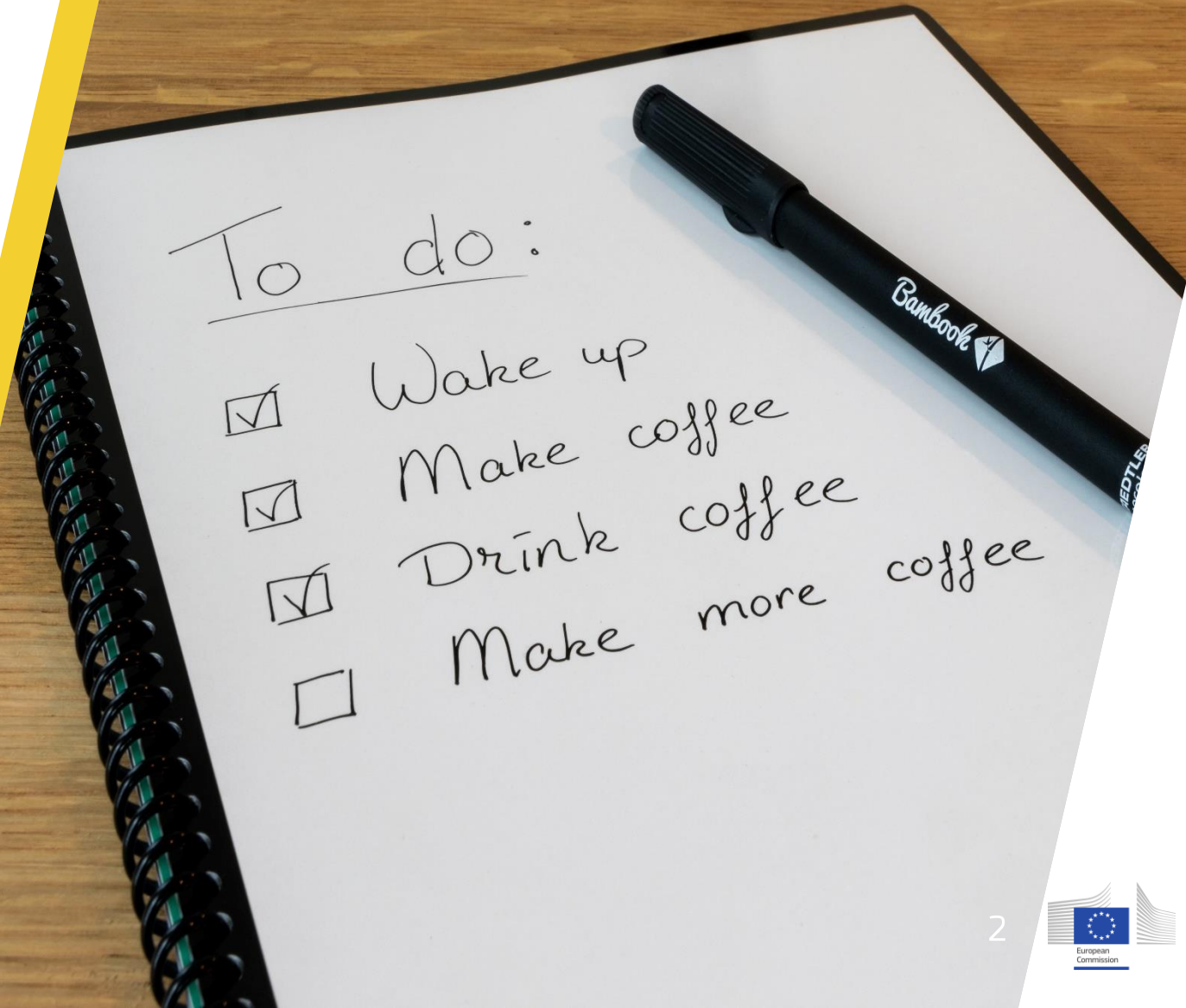

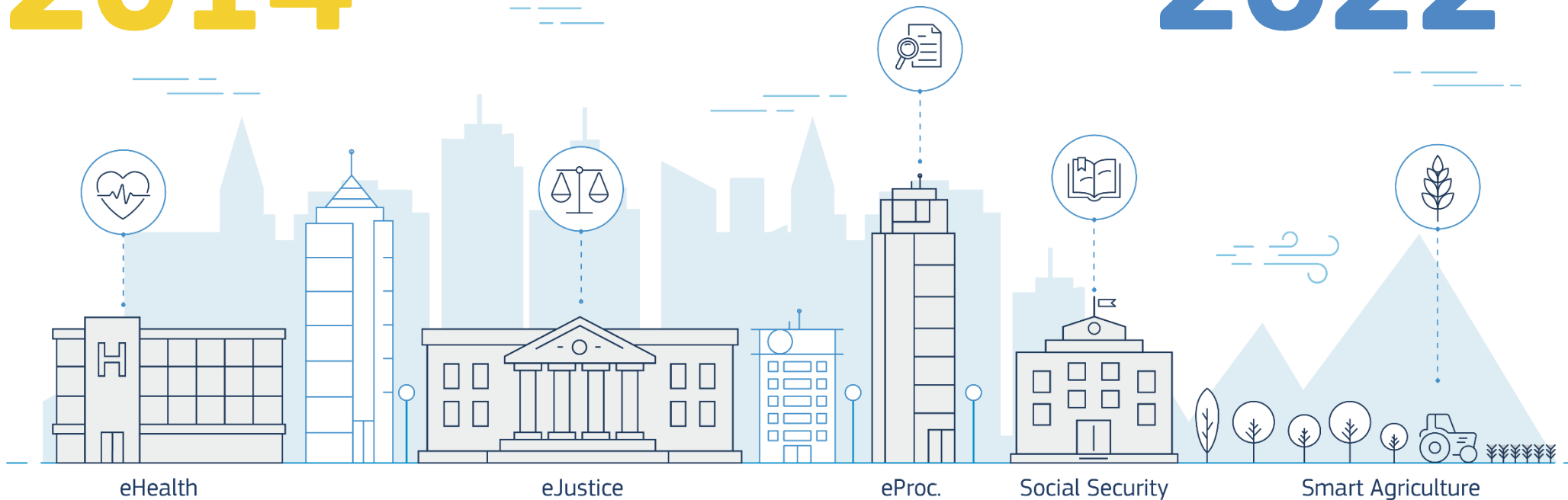

- **150%** increase in reuse since 2018.

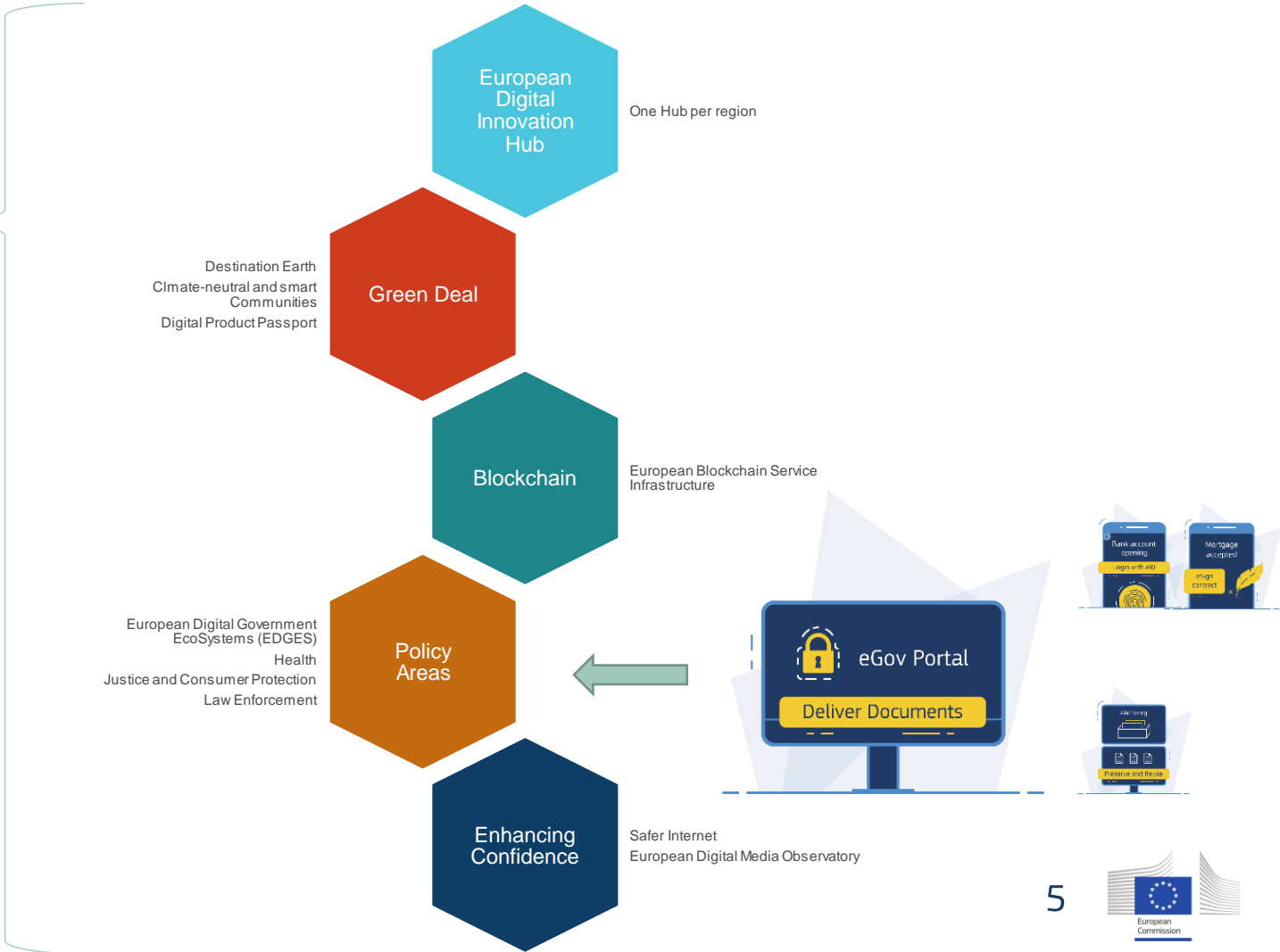

Grants

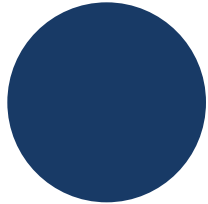
- 6 calls for grants, last one in 2020
- Budgets between €500k and €1M
- Last eDelivery action ended in September 2022

Results

- 23 grants contracted
- 63 Access Points deployed
- Total EU budget €5.16M with total costs of €6.95M in 19 MS, 2 EEA countries and one former MS (UK)

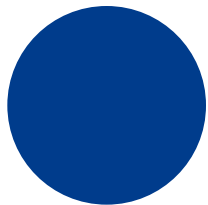

What's next for eDelivery grants?



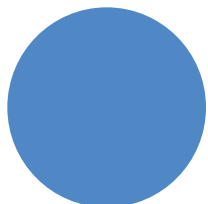
No specific funding

Specific funding for eDelivery is no longer available at the European level.



Funding as part of larger actions

Funding of eDelivery-related work may be eligible as part of larger actions under call priorities established in a Digital European Programme Work Programme, especially if under Specific Objective 5.



Funding at national level

Funding may be available from specific Member States as part of the national call for proposals using EU funds (NextGenerationEU).

Security changes to eDelivery AS4 profile

Objectives

New cryptography

Update cryptographic primitives to switch from RSA-based algorithms to more modern/secure ones (EC-based)

Better security

Define optional security enhancement to enable Perfect Forward Secrecy for eDelivery encryption

Updated TLS recommendations

Review and update the eDelivery recommendations concerning the use and configuration of TLS

Updated SMP specifications

Update the SMP specification to allow parties to publish metadata that can allow a gradual migration to the new cryptography

Design to avoid “big bang” switch from old to new cryptography (allow networks to transition gradually)

Updated SMP specifications

Objective

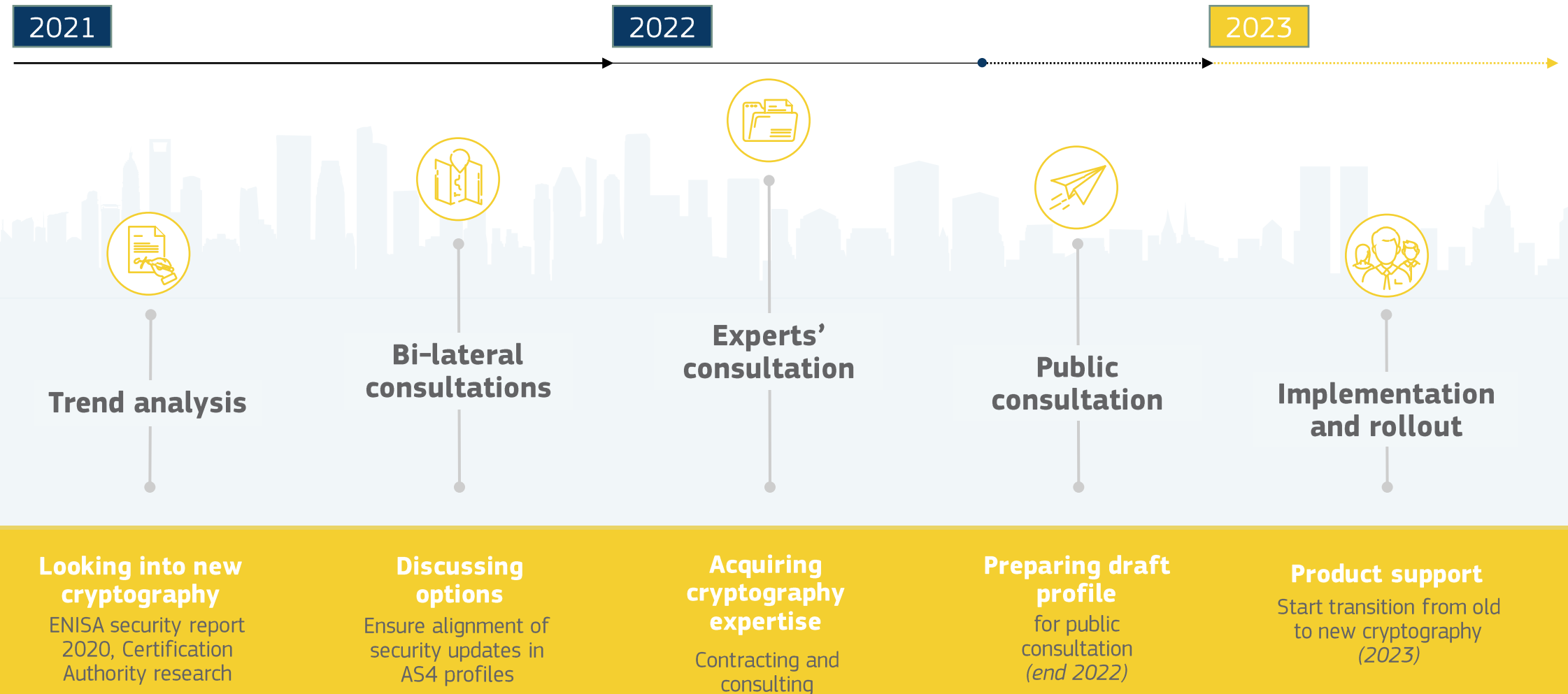
- Co-existence of RSA and EC metadata
- Tentative: publish separate certificates for signature and encryption
- Ensure backwards compatibility

Approach

- Use of multiple SMP transport profiles
- Adopt SMP 2.0
- No changes to current transport profile

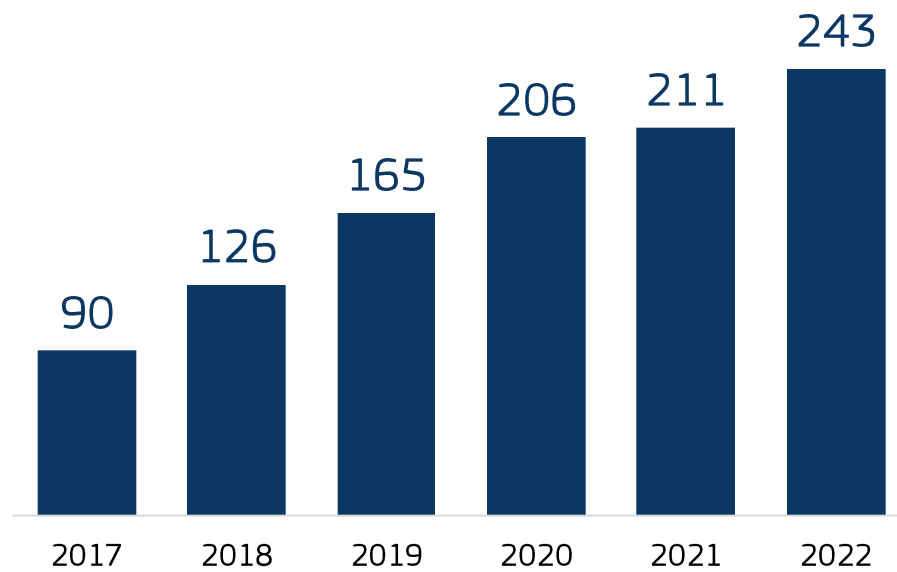

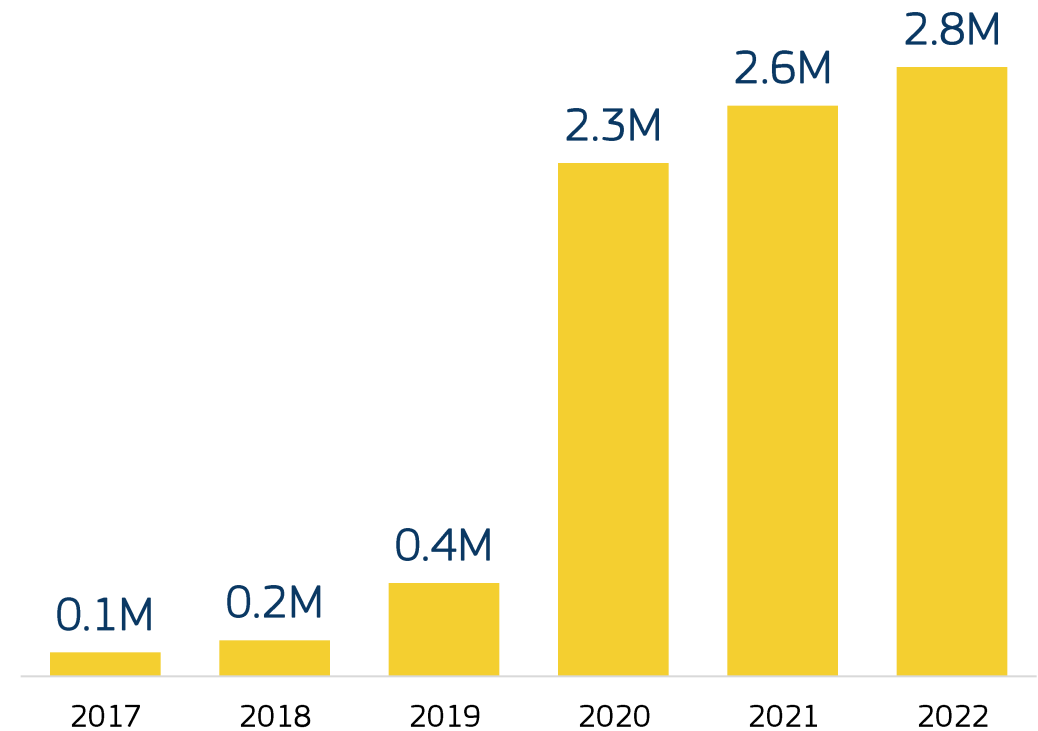
