Making Quarters

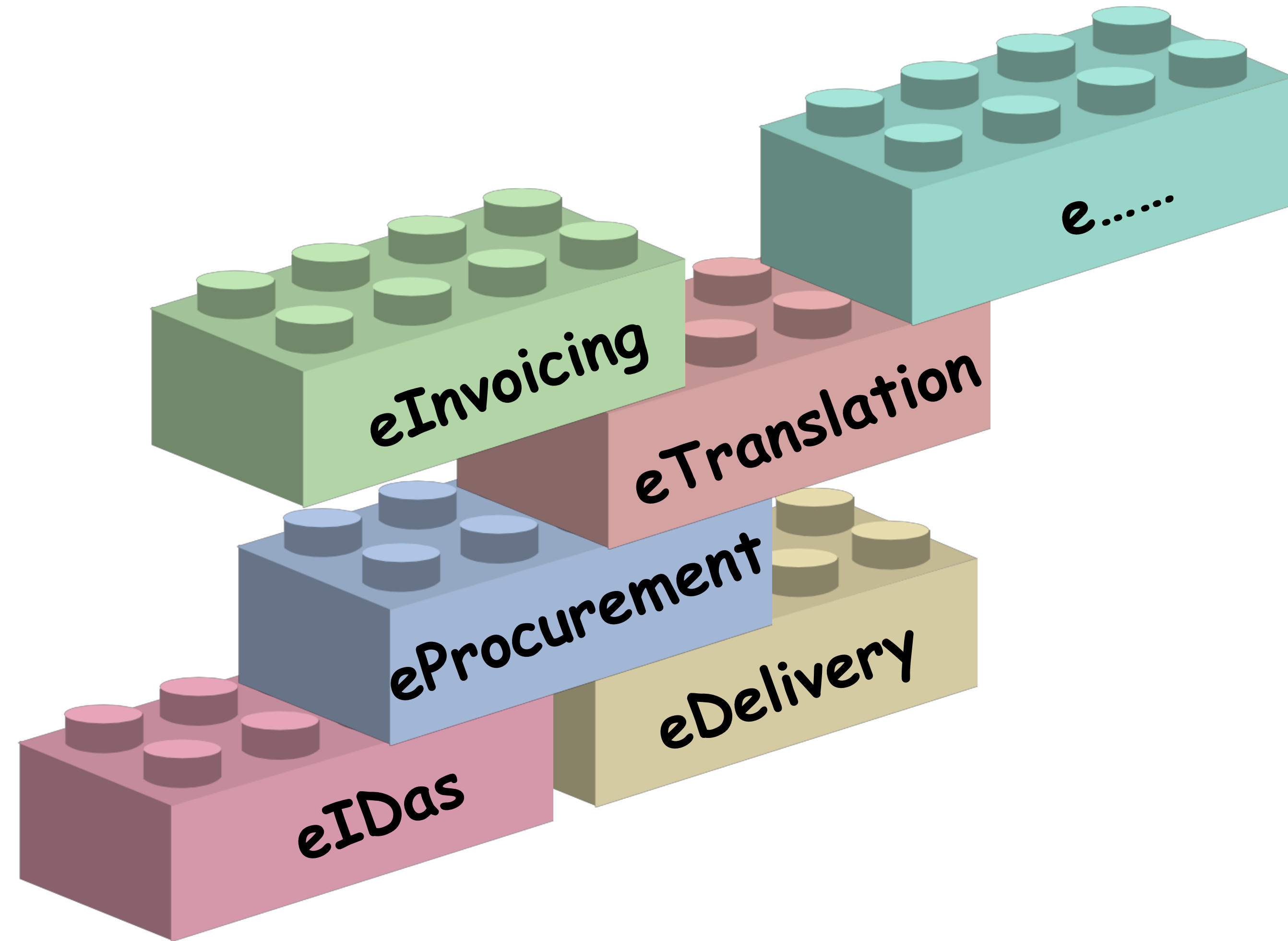
The objective of “making quarters” is to set up, implement and deploy the Program-Office International.

8. Maintaining regular contact with relevant European authorities and programs.

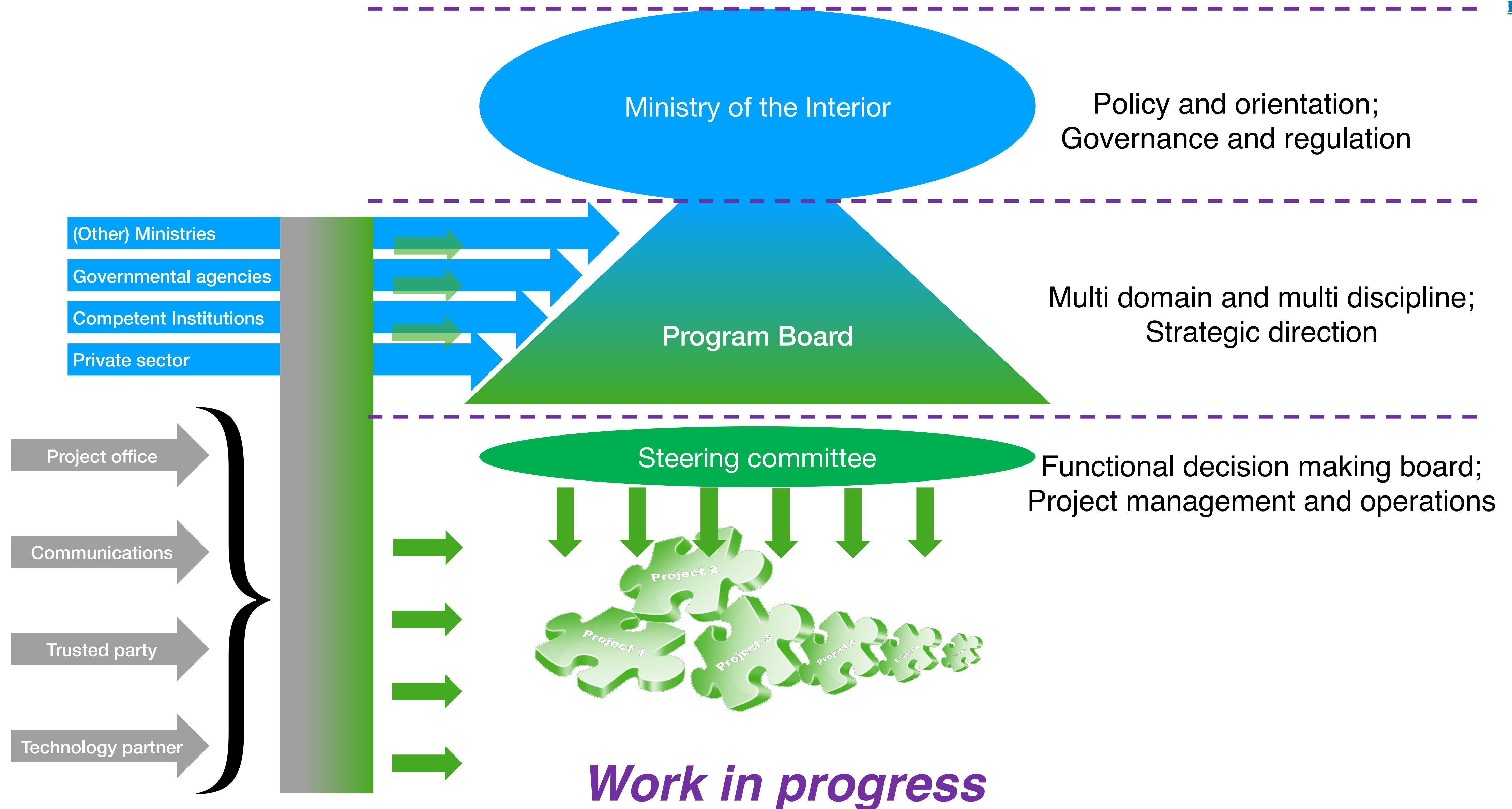
Work in progress

Core activities Program-Office

1. Cohesion and cooperation: Stimulating cohesion and providing context in the activities which are, at the moment, being executed individual parties.
2. Knowledge: sharing, coordination and communication about international interoperability.
3. Single Point of Contact: Acting as a national contact point for the EC concerning implementation and execution.
4. Effect: Achievement of cost savings by means of programmatic synergy.
5. Means, Motive and Opportunity: Stimulating the the use- and facilitating the utilization of national and European possibilities of (additional) funding.
6. Research and development: Prospecting and development of new and/or complementary services and applications.
7. Alignment: Coherent business-IT-alignment and translating this into project initiatives.
8. Support: Project support office in new and running projects.
9. Communication: Promoting the use of National as well as European DSI building blocks.
10. *National: Program office Taskforce Single Digital Gateway.*
