Partnership with the Commission

European Commission

Defines the policy

- Defines strategy, objectives and priority areas/work programmes
- Selects actions for co-financing
- Makes programme decisions
- Evaluates the programme and the Agency's performance



INEA (Executive Agency)

Turns policy into action

- Manages the project lifecycle:
 - Organises Calls for Proposals and external evaluations
 - Monitors technical/financial implementation of projects
 - Manages communication actions (Info Days, website, publications)
- Provides feedback to policy making

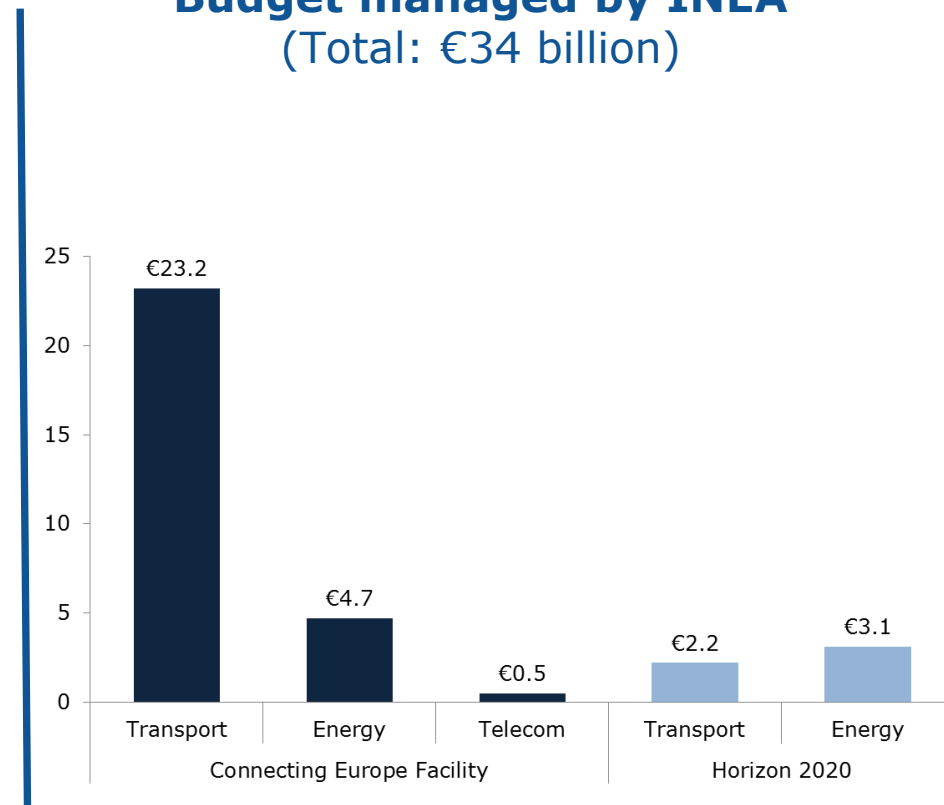
MFF 2014–2020

Which Digital Service Infrastructures?

- **Five building blocks**

eIdentification, eSignature, eInvoicing, eDelivery and eTranslation.

- **10 sector specific DSIs**

Safer Internet, Online Dispute Resolution, Public Open Data, eHealth, eProcurement, Business Registers Interconnection System, Electronic Exchange of Social Security Information, European e-Justice Portal, Europeana and Cyber Security.

- 46 calls between 2014 and 2018 (allocating €230.2 million to 390 actions).

What is covered?

- Deploying access points and/or operating access points for one year.
- Deploying SMPs and/or operating SMPs for one year.
- Upgrade of data exchange solutions (Commercial Off-the-Shelf, Open-Source Software and other) to support (and therefore fully comply with), the CEF eDelivery standards (*which can also cover interoperability testing with new or existing conformant solutions*).

Proposals addressing eDelivery activities (a) and (c) can cover the transition from the AS2 to the AS4 message exchange protocol within the PEPPOL eDelivery network or any other similar initiative.

*Under 2019-2 call to be launched on **04/07/2019** and closed on **14/11/2019***

(indicative dates) the following DSIs may support eDelivery, where relevant:

- ***Business Registers Interconnection systems***
- ***European e-Justice***
- ***eProcurement***

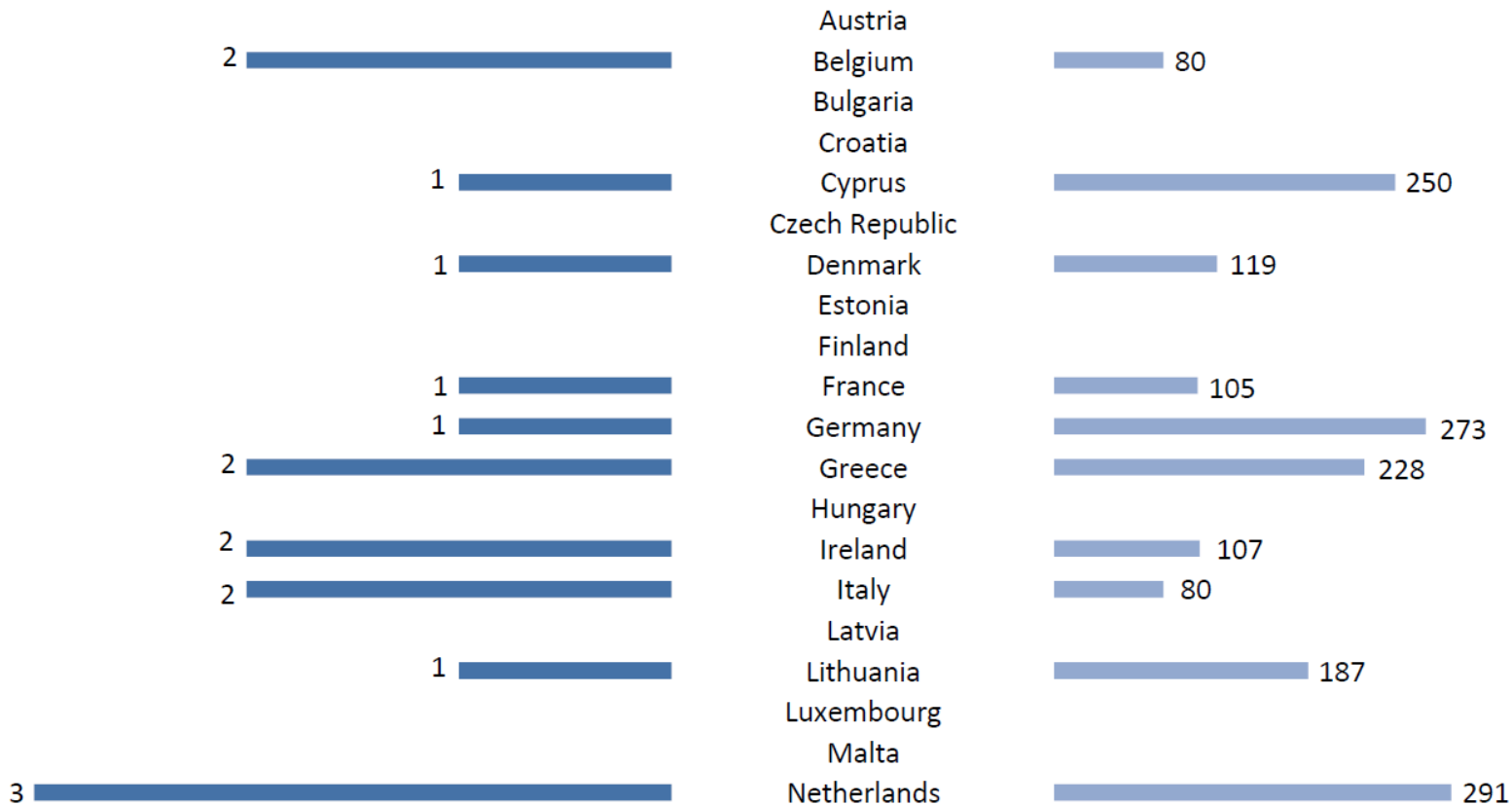
eDelivery implementation by INEA 2015 - 2018

- *First call in 2015 and then each year, APs supported as of 2015, SMPs as of 2016*
- *12 agreements signed by end of 2018 with a total of € 3.2 million of CEF funding*
- *In 17 Member States and two EEA Countries, corresponding to a total cost of €4.4 million*
- *Support for deployment of 30 APs under the eDelivery DSI*

Number of projects and CEF funding (€ thousand)

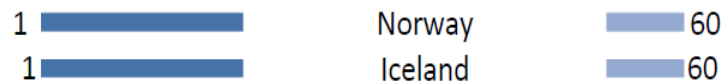


CEF grants for eDelivery until 2017

eDelivery implementation by INEA 2018-2 call

- *Under the 2018-2 call three proposals were selected for CEF funding for a total amount of € 632,976 – Grant Agreements are under preparation*
- *A further 7 AS4 Access Points and SMPs within PEPPOL network will be supported + 1 eDelivery Access Point*
- *Newly supported countries: Finland, Hungary*

Reuse of eDelivery with CEF funding

eDelivery is also deployed as part of several Grants awarded under the following DSIs including:

- *eInvoicing,*
- *eJustice*
- *Business register interconnection systems (BRIS)*
- *Automated Translation*
- *eProcurement*

In total: 49 APs supported
